45(E) HACKNEY CARRIAGE/PRIVATE HIRE VEHICLE DRIVERS' LICENCE - DR816 ILL HEALTH, FAILURE TO REPORT ILL HEALTH

The Head of Environment and Highways reported on a currently licensed driver whose licence renewal application had not been determined on the basis of her medical records.

He explained that the driver's previous licence had been extended until the Board made it's decision, but during this extended period the licence had been suspended and the driver had not been permitted to drive a hackney carriage/private hire vehicle.

The Licensing Board was asked to consider whether she was a fit and proper person to hold such a licence in view of her ill health, taking prescribed medication that could affect her fitness to drive, associated alcohol abuse and the failure to notify the Council of these issues.

The driver was not in attendance, but due to the seriousness of the matter the Board agreed to hear the case in her absence.

RESOLVED – (By 3 votes to 1) that the renewal application for Driver No. DR816 be granted and suspended immediately upon renewal for a period of six months expiring on 20 August 2003. During this period the driver is required to undertake a medical examination by a qualified psychiatrist and obtain and produce a report in writing stating her fitness to drive a hackney carriage / private hire vehicle. The Driver is required to meet the costs of the medical examination. Upon expiry of the period of six months or upon production of a medical report (whichever is the earlier) the matter will be brought back before the Board for determination. The Driver is requested to attend.
