Purpose of Report

- 1. To advise Members of the year-end actual performance by the staff in the Corporate Resources Directorate against the targets and milestones set out in Part II of the Corporate Plan for 2009/10.
- 2. To note the areas of shortfall in performance and the actions that will be taken to improve performance during 2010/11.
- 3. To seek Members' views on the performance indicator targets for the activities overseen by this Committee for 2010/11 to 2012/13.
- 4. To note that this information will be published in Part III of the Corporate Plan, to be agreed by Cabinet on 14th June 2010, and summary details will be included in the Council's Annual Report to be published later in the summer.

- 1. That Members note the information that will form Part III of the Corporate Plan
- 2. That the comments of the Overview and Scrutiny Committee on the proposed performance indicator targets for 2010/11 to 2012/13 be referred to the Cabinet meeting on 14th June 2010.
- 3. That the Overview and Scrutiny Committee thank staff for their hard work in achieving the targets set out in the Corporate Plan.



Reasons for Recommendations

To assist with the approval process for the Corporate Plan Part III and assist Overview and Scrutiny Committee Members to undertake their Performance Management role.

Introduction

- 1. The Council meeting on 24th February 2010 agreed Parts I and II of the Corporate Plan 2010/11 to 2012/13 these documents set out the Council's work-plans for 2010/11.
- 2. Part III of the Corporate Plan contains a report back against the milestones and targets set out in Part II of the Corporate Plan relating to 2009/10 and sets out the performance indicator targets for the next three years.
- 3. The 15th June Cabinet has been given delegated authority by the Council to agree Part III of the Corporate Plan prior to publication by 30th June.

Retrospective Performance Report Back – Appendix A

- 4. Appendix A provides a report back on performance during 2009/10 against the Corporate Plan targets for the Directorate and Services relevant to this committee.
- 5. The status of each target as at 31st March 2010 is described as either:
 - G = Green Target achieved
 - A = Amber target changed, affected by external circumstances or narrowly missed
 - R = Did not hit target also includes description of how we will address this in 2010/11
- 6. The narrative accompanying the target gives some further information and explains what actions will be undertaken in 2010/11 to address areas identified as Red or Amber.

2009/10 Performance Indicators – Performance against targets – Appendix B

- 7. Appendix B reports on year-end performance against the indicators set out in the Corporate Plan, which O & S have been monitoring during the year.
- 8. The tables in appendix detail performance against targets for 2009/10 for all Performance Indicators for Directorates relevant to this Committee as well as targets for 2010/11 2012/13.
- 9. Where changes to targets are proposed these are clearly indentified in the text, with reasons given. These changes remain subject to Cabinet approval.

Financial Position

10. Work is ongoing to finalise the Council's year-end position in respect of both revenue and capital expenditure. The Audit Committee will consider a comprehensive report on the final position in June. Based on provisional figures no overall overspend is anticipated.
