## Cabinet Meeting held on 28 November 2011

#### 73. HALF YEAR PERFORMANCE UPDATE

#### Decision:

that progress made in delivering against the 2011/12 commitments and targets, and the actions taken to address potential shortfalls be welcomed.

# 75. MEDIUM TERM FINANCIAL STRATEGY AND 2011/12 MID YEAR FINANCIAL REVIEW

#### **Decision:**

# 76. BANKING SERVICES CONTRACT

- (1) the Council join the new Eastern Shires Purchasing Organisation's (ESPO) framework agreement for banking services after 1.4.12 and responsibility be delegated to the Head of Financial Services (under Financial Regulations and Financial Operating Procedures) to finalise the arrangements following mini-competition in accordance with the terms and conditions of the framework agreement; and
- (2) the existing agreement with the Co-operative Bank be extended by 12 months after 1.4.12 to allow sufficient time to carry out a mini-competition exercise in order to comply with resolution (1) above.

The new ESPO framework was expected to offer the most effective way of securing value for money in banking services over the medium term.
