# **Background**

- 1. A Scrutiny Review to examine Hastings Borough Council's (HBC) Consultation process was included in the 2009/2010 Overview and Scrutiny annual work programme. The review began in August 2009, concluded in February 2010 and fell within the remit of the Resources Overview and Scrutiny Committee.
- 2. The recommendations from the Review informed a refresh of the Council's Participation and Communications Strategy and the recommendations for action were embedded in the associated Action Plan.
- 3. The refreshed Participation and Communications Strategy and Action Plan was agreed by Cabinet in May 2011 following public consultation and the Resources O & S Committee have been monitoring progress against targets as part of the 2011/12 Quarterly performance Review reports.

## **Progress Update**

- 4. The majority of targets in the 2010 Participation and Communications Strategy and Action Plan have been met. Appendix A sets out progress against each theme and action as agreed.
