
# APPENDIX A – HASTINGS BOROUGH COUNCIL OVERVIEW & SCRUTINY CHARTER (Draft)



### What does Overview and Scrutiny do?

Overview and Scrutiny holds decision makers accountable for their decisions and makes sure the council works in a way which is clear and easy to understand. Overview and Scrutiny also keeps track of how the council is achieving its priorities and looks at improvements to the way we do things. A key part of Overview and Scrutiny is working with the local community, so you can tell us what's important to you and have your say.

#### As a local resident:

Overview and Scrutiny will:

- be a 'critical friend' to decision makers, and make sure the council is achieving its priorities in the most efficient way possible.
- look at issues which are important to the local community.

### As an Overview and Scrutiny Member:

- Overview and Scrutiny is an a-political process, all Members will be given the opportunity contribute at meetings and ask questions of Lead Members, officers and other attendees.
- Members will be encouraged to take an active role in committee meetings, reviews and the wider Overview and Scrutiny Work Programme.
- If Members have invited a representative from an outside organisation to attend a meeting, Members questioning must be appropriate.
- Overview and Scrutiny Members will make an important contribution to formulating the Council's priorities and budget, and monitoring their implementation.

#### As a partner organisation:

- Those assisting the committee by giving evidence will be treated with respect and courtesy.
- Members questioning will be relevant to the topic being discussed, where possible a list of questions will be provided to the attendee in advance of the meeting.
- Any minutes, reports or recommendations arising from the meeting, will be sent to the partner organisation, for their information.
- Whilst outside organisations can not be compelled to attend Overview and Scrutiny Committee meetings, their continued co-operation is appreciated.


