1 WELCOME AND APOLOGIES FOR ABSENCE

Marie Casey welcomed everyone to this meeting of the LSP Board and introductions were made.

Suzy Lawrence-Strachan from the Down's Farm Community Centre gave a short briefing on the facilities and functions of the centre and its role in the local community.

Marie thanked Suzy and other volunteers for the use of the building and the provision of refreshments.

2 NOTIFICATION OF URGENT ITEMS

Marc Turczanski requested an update on the community trigger provisions of the Anti-Social Behaviour Crime and Policing Act which come into force today. A key element of the Act is the introduction of a "community trigger", which gives victims the right to request a review of their case to ensure relevant agencies are working together to practically resolve the matter and address service recovery issues when needed.

Cllr Birch reported that proposals have been considered at HBC Cabinet and referred to full Council for adoption. It recommends that the community trigger threshold for Sussex would be initiated when an individual has made three complaints of anti-social behaviour or hate crime in a six month period. The full report is available on the HBC website.

Mike Thompson also reported that Amicus Horizon have been making provision to support residents who may be affected.

It was suggested that the Safer Hastings Partnership would be further discussing the way forward and after their next meeting a briefing note may be available for circulation to the Board and its Executive Delivery Group.

3 DECLARATIONS OF INTEREST

With reference to the discussions on Education:

Steve Manwaring declared his position on the Board of the Hastings Academies Trust, the Education Futures Trust and a governor of the Baird Primary Academy.

Simon Hubbard declared his position on the board of the Education Futures Trust and as a governor of South Coast College Hastings.

Julie Eason is a governor of the Hastings Academy.

4 MINUTES AND MATTERS ARISING

4a MINUTES FROM THE LAST LSP MEETING ON 21ST JULY 2014 TO APPROVE

The minutes of the last Board meeting held on 21st July 2014 were approved as an accurate record with the following amendment:

(4) Ron Bennett requested that the minutes be changed to reflect that the Big Local project is operating in *North* East Hastings not East Hastings as stated.

4b **MATTERS ARISING**

- (3b) Heron House At the last EDG meeting Bruce Campbell reported that the Job Centre will not be required to vacate its premises at Heron House as there is a contractual agreement for them to remain for at least another 3 years.
- (5) DESSS Steve Manwaring reported that an initial meeting has been held to identify and contact small grants providers in the area to promote the Discretionary East Sussex Support Scheme.

Cllr Birch reported that any underspend from last year will be reinvested in the current years allocation.

Julie Eason queried how this underspend was allowed to accrue. There were many applications submitted but high proportions were unsuccessful. Cllr Birch agreed to look into this further.

- (6) Strategic Transport Cllr Birch reported that County Council's bus service consultation has now concluded and the outcomes are expected to be announced in December. Stagecoach have already committed to run a couple of routes previously identified as at risk on a commercial basis, although others may still require additional subsidies in order to continue operating.
- (9) GP First Mark Turczanski reported that he has contacted NHS England for more information about the GP first scheme. The programme is being rolled out nationally but lead locally by individual practices. So far, there have not been any further reports of patients being negatively affected by this new way of working but continued monitoring will be necessary.

Emma Cuppini from the Hastings and Rother Clinical Commissioning Group committed to look into any potential effect on vulnerable groups and report back.

5 KEY FINDINGS FROM EDUCATION AND ACCOUNTABILITY CONFERENCE

Steve Manwaring gave a report on the outcomes of the last Hastings Community Network event around Education and Accountability. Centred on the local community, the event focussed on what further steps can be taken from early years to adulthood to ensure the best educational offer and achievement.

Areas of particular emphasis were pupil movement between schools, exclusions, how to promote services to pupils and their families, links between the voluntary sector and agencies and how to promote the local Credit Union.

The University of Brighton who co-hosted the event identified two strands for further research

- Identifying good practice models of accountability in other areas
- Pupil premium resources and how they are utilised

The conference was a great success overall and a follow up event is now planned to take place in 2015.

The next quarterly HCN event will explore demographic changes and community cohesion.

6 SUPPORTING EDUCATION LOCALLY

6a ARK WILLIAM PARKER ACADEMY - ONE YEAR ON

Mark Phillips, Principal of the William Parker Academy was in attendance to update the Board on the Academy's progress. He reported that the two main areas of focus have been academic attainment and safeguarding children.

Good progress has been made in both these areas:

GCSE attainment A-C increased from 42% to 59% although more work is needed to improve English and Maths performance and humanities subjects. The sixth form, run jointly with Helenswood, has been relaunched with a continuing focus on A level attainment.

A lot of work has been undertaken around the culture of the school including a strong anti-bullying programme, a mentoring scheme, interaction between year groups and the reintroduction of Personal and Social Education to the curriculum.

Work to improve attainment and culture will continue but equally important challenges to address are pupil literacy and recruitment and retention of quality staff. Converting the previous 'inadequate' Ofsted rating to 'satisfactory' will be the first step toward what will hopefully be continued improvements.

6b HASTINGS ACADEMIES TRUST - PROGRESS TO DATE

Paul Griffiths, Dean of Regional Education and Academies Development and Chief Executive of the Hastings Academies Trust, gave an update on the work of the University as education providers and academy sponsors. The Trust aims to provide high quality education, address underperformance and maximise attainment; its work has expanded greatly with student numbers steadily growing.

The Trust also recognises challenges to achieving its aims such as reducing in year admissions, capacity for special needs provision, providing social and mental health support to students, reducing the proven attainment gap between free and non-free school meals, recruitment and retention of staff and parental engagement.

7 EDUCATION IN HASTINGS

Stuart Gallimore and Fiona Wright from East Sussex County Council were in attendance and gave a presentation to the Board including information on:

- Background information and provisional results for 2014 Key Stage 4
- Follow up actions as a result of the Ofsted inspection carried out in June.
- The Excellence for All Strategy which details the aims and targets for improvements up to 2015.

Stuart highlighted that the legislation clearly states the County's accountability to ensure all children in East Sussex receive a good education, whether schools are academies or not. Despite Ofsted's 'ineffective' ruling earlier this year, the Excellence for All Strategy is recognised as the right path for improvement.

EDUCATION DISCUSSION

The Board thanked all three speakers for their contributions, a general discussion ensued. The importance of good schools and educational attainment was recognised as integral to achieving regeneration and its impact on the community as a whole and all partners voiced their commitment to supporting these aims.

A number of concerns were raised including:

- Destination figures for students are key indicators of success, do we collate these statistics?
- What value the Academies add and why recruitment is not improving.
- Clive Galbraith raised his concerns that the Education for All Strategy is not easy to understand and is overly reliant on targets; there is very little about employment.
- What measures are being taken to support pupils at risk of being excluded?

Paul Griffiths said that increasing the numbers of University students will hopefully give them a sense of belonging to the area and make them more likely to put down roots, leading them into employment and retaining their skills. Close working between teacher training and student unions will also help.

Having one spokesperson for all academies is being explored to give a more cohesive impression.

Stuart Gallimore gave his assurance that the EFA Strategy is fit for purpose but did recognise the need for more focus on skills to gain employment and engagement with local businesses.

Fiona Wright recognised the problems with in year admissions and assured the board that work is ongoing with schools across the county to try to resolve this. A working group has been set up in Hastings to explore how to reduce school 'hopping'. Resources to prevent exclusions is part of the overall budget for individual schools, they are able to tackle this themselves or buy in expertise from County.

Jenny Jones also championed the work being undertaken by the academies and other education providers throughout the town. The figures are important but also is the quality of work being carried out which boosts confidence and success for students. She did however concede that resources to support the complex range of social and educational needs for many children are stretched.

Information on College Central and exclusions was requested, Fiona Wright agreed to bring this to a later meeting. The Board as a whole recognised that as important as education is, it is part of a bigger picture and how all partners can work together contribute to improvements in a broader perspective is key to making progress in regenerating the town.

9 SEAWATER BATHING QUALITY

Virginia Gilbert from Hastings Borough Council, David Tyler from Southern Water and Richard O'Callaghan and Liz Lewis from the Environment Agency were in attendance for this item.

Virginia reported that a number of measures have been undertaken to improve seawater quality tests at Hastings, initial results show that some progress has been made but the outcome of the official tests may still find that we do not meet the required standards.

David Tyler gave a presentation outlining further work which has begun to identify problematic 'dual manholes' and misconnected properties particularly in the upper Hastings catchment area. Southern Water has limited enforcement powers but is working closely with partners to address these issues.

Our minimum aim is to achieve a 'satisfactory' outcome when Defra undertake their official testing next year although we will have a better idea of our progress when sampling results are received next month.

The Board welcomed the measures that have been implemented, they questioned the main risks in achieving a satisfactory rating. How other alternative solutions and value for money are being considered was also queried.

Richard O'Callaghan said that the ratings will be based on four years' worth of data and so even if next year's readings are within the acceptable levels, sustaining these improvements will be the real challenge. The weather will also have an impact on our success as heavy rainfall will result in a higher level of bacterial contamination out at sea.

A cost/benefit analysis has been carried out on other options in the interest of achieving the best and most sustainable outcome for the best price. Alternative solutions include diverting the Alexandra Park stream and extending the seaward outfall pipe. Southern Water is continuing to collate data; it is possible that these options may be furthered in the future but are currently not considered suitable short term solutions.

LSP Draft Terms of Reference

This is the constitution of the Hastings and St. Leonards Local Strategic Partnership (LSP).

This constitution does not change, replace, substitute or amend in any way the statutory duties or other responsibilities of partners.

It does not change, replace, substitute or amend in any way partners organisations' own management or accountability frameworks, or prevent any individual partners' organisation from pursuing its own individual actions.

Local Strategic Partnership members shall work together and individually in the spirit of trust, fairness and mutual co-operation. The work of the partnership is rooted in a spirit of cooperation and we affirm the value of acting in partnership with others to improve the lives of those who work and live in Hastings.

Roles and Authority

The main general role of all Members of the Partnership will be to take a town-wide perspective and to develop consensus in the best interests of the town as a whole.

Members will be recognised for their valuable contribution in bringing ideas, knowledge and expertise to the process.

Whilst recognising that decisions about the use of resources will still remain the preserve of individual partners, there is a need to establish consensus endorsement of strategic issues, while encouraging opportunities for better ways of working, joint working, delegation and joint or shared resources where appropriate. Members will need the appropriate authority to speak on behalf of their relevant organisations (proportionate to their role within the organisation).

Legal Status

The LSP is an informal partnership. It does not have legal status to enter into contracts and will act through partner organisations as appropriate.

Hastings Borough Council will act as the Accountable Body for financial matters on behalf of the LSP. All accounting arrangements will be made under the supervision of the Head of Corporate and Democratic Services.

Key Tasks

- Be Strategic, Representative and Effective
- Identify and report strategic issues, which the Hastings and St Leonards Local Strategic Partnership should be aware of
- Provide strategic leadership on any Borough wide issue, identified by partners and agreed by the LSP, where no other appropriate existing organisation or partnership can be identified
- Act to bring together intelligence, expertise and community and business support to identify priorities and develop solutions to maximise the town's economic opportunities and address barriers to regeneration
- Motivate partners to look for new ways to improve
- Ask challenging questions about and scrutinise performance
- Deal honestly and robustly with under-performance

- Minimise bureaucracy and build upon existing structures helping to demonstrate that we
 have reduced and not added to the 'bureaucratic burden'
- Focus on the needs of the whole Borough, with an inclusive concern for all citizens, especially the marginalised and disadvantaged
- Consider what is in the best interests for the common good of Hastings and St. Leonards and weigh this along with the interests of individual organisations on the Board and their sector when making decisions

LSP Membership

- The LSP will consist of senior representatives from those organisations playing a lead role in the town.
- The composition of the Board will be as *inclusive as practicable* covering a full range of "key players" balancing this with a realistic maximum size of partnership necessary for it to be effective and strategic.
- The Board will need to secure the involvement of all the appropriate key players, including the public, private, community and voluntary sectors. This should allow engagement of residents, community, other public sector and business interests that cannot be represented directly on the Local Strategic Partnership.
- Each member of the Board can name one alternate to attend in his / her place
- LSP Board members agree to champion and communicate the partnership arrangements of the LSP throughout their organisation, partnership and sector.
- If a member of the LSP changes to a different employer or loses his or her position, then their membership of the LSP will automatically cease with immediate effect.

Briefing Note re Director of Public Health Annual Report 2014/15

This annual report focuses on how we can build resilience by growing the assets of wellbeing across East Sussex. Assets are any factor (or resource), which enhances the ability of individuals, communities, and populations, to maintain and sustain health and wellbeing and to help to reduce health inequities. This includes the skills and capacities of the individuals, the formal and informal networks and associations, the institutions, the land and other physical assets within a community.

It looks at how we can identify, better understand and support development of existing and potential new community assets. It focuses on identifying the key features of asset-based approaches and how we can make further progress in a sustainable manner. It initially focuses on describing what an asset based approach involves and how it is different from focusing on deficits in the current services and support people receive. It describes how individuals can play a significant role in increasing community resilience. The report describes how systematic processes can be used to support this work and monitor its impact particularly in developing sustainability.

Based on a review of the evidence, this report recommends further work to enhance community resilience which seeks positively to develop, harness and mobilise the assets, capacities and resources available to individuals and communities to enable them to gain more control over their lives and circumstances and to meet primary prevention, health, wellbeing and social care support needs.

The second part of this report sets out a relatively new way to measure the wellbeing and resilience of communities. It describes a tool – Wellbeing and Resilience Measure (WARM) – that has been designed to support local agencies and communities to better understand, plan and act. WARM provides a way of understanding and identifying an area's strengths, such as levels of social capital, confidence amongst residents, the quality of local services or proximity to employment; as well as vulnerabilities such as isolation, high crime, low savings and unemployment. The tool identifies these factors using routinely available information.

WARM has been calculated for East Sussex at ward and district and borough level and also modelled at clinical commissioning group and GP practice level. All the WARM maps at ward and GP practice level are available to download as separate documents above.

The report concludes by summarising the approach outlined in the report and, drawing on the evidence and best practice, looks at the ways in which the skills, knowledge, connections and resource of individuals, communities and organisations might best be captured, harnessed and strengthened. The report makes ten recommendations for supporting community resilience in East Sussex.

BRIEFING NOTE ON REGENERATION

Employability & Apprenticeships

- Employability Forum met December 2014 to review the progress of the Own Grown initiative and its priorities for 2015, Local Economic Partnership/EU funding opportunities, and the Hastings Into Work partnership.
- Academies Employability Action Plan Heads have agreed to sign Academies/Business engagement charter. Dates agreed for CV/interview speed dating sessions with pupils and business representatives.
- Two Business Breakfasts held in Old Town and St Leonards with 30 attendees in total.
 Workshop on social media, funding finder and commitments to pledge to Own Grown. Further breakfast planned in January for Town Centre, linking in with Business Improvement District work.
- Two sector-based Creative Cafes delivered in partnership with Culture Shift with a total of 135
 Academy pupils engaged. Pupils work in a café style setting with businesses on practical tasks
 relating to a particular sector (eg drafting a week's staff rota for a hotel). A further two creative
 cafes are planned for spring/summer terms.
- Own Grown Challenge 2,014 pledges achieved on 20th November 2014. As of 5th December currently tracking at 104%.HBC taking a leading role in managing the project, including 1-2-1 brokering, social media/publicity
- Own Grown 2015 target as a partner in county-wide apprenticeship challenge You're Hired:
 East Sussex 500 apprenticeship pledges from businesses, 500 pledges from young people who wanted assistance to be ready to take up an apprenticeship across 5 boroughs over 5 months. Alongside this, Own Grown will continue to actively engage and broker other types of pledges (such as work experience, work with schools, mentoring etc.) with businesses.
- January July 2015 Own Grown will audit/measure and evidence the impact of the previous 2 years' of pledges for the purpose of potentially bidding for European funding for 2016.

Evening and Night Time Economy and Student Town

• Preparations are under way for a 'Hastings Exchange' forum event at the University of Brighton to engage with local business. It is jointly organised with HBC to discuss the broad topic of making the most of Hastings as a University Town. This will target the service economy including the evening and night time offer and will address key issues to promote what the University can offer the local community and businesses in terms of opportunities to engage. Student voices will also be heard, and experience will be drawn from similar seaside towns where a university campus has integrated well. It will be held in March 2015. Hastings Town Centre Management and HBC have held three meetings with town centre businesses to progress proposals to establish a Business Improvement District (BID) in the area. A steering group has been established, chaired by David Padmore (McDonalds franchise), which is meeting monthly. A survey has also been distributed to 235 businesses and an awareness raising session is being held at Sussex Coast College Hastings at a business breakfast 8-10am January 30th 2015.

Hastings Community Network Update

CULTURE EXCHANGES 6th October 2014 Jerwood Gallery, Hastings

Culture reflects our way of life, providing a lens through which we see ourselves and is central to the way we develop a sense of identity within our community. It's a vehicle for self expression and creativity as well as an important contributor to health, a sense of wellbeing, and inclusion in community life. Forty Six people attended the event, sixteen from arts organisations, twenty four from the voluntary and community sector and six from the statutory sector came together to explore the value of culture and its potential impact on health and wellbeing, social wellbeing and inclusion, education, economic regeneration and tourism. It also provided a space for discussion and exchanges between community groups and arts organisations and explore opportunities to work together.

Community Cohesion will be the focus of the next HCN event in March. This is being planned in partnership with HBC.

Update for the Local Strategic Partnership Bathing Water Quality (Hastings)
January 2015

Actions since your last meeting:

Sewer and Misconnection Investigations

Southern Water's programme is proceeding at a rapid pace now. The focus is directed at correcting faulty dual manholes (where foul and surface water sewers run side by side), particularly in the former private sewer networks which were adopted in 2011 but are poorly understood.

There are not very many more misconnected households uncovered so far. It may be that most have already been identified and corrected but the search continues.

Southern Water is issuing very optimistic statements that their current programme, if assisted by reasonable weather during the 2015 season, will be sufficient to assure the Hastings will meet the new standard. The EA is more cautious at this stage, although they also detect improving trends, as there is not enough statistical evidence yet.

Alexandra Park

The final phase of Alexandra Park treatment works is scheduled to begin in February and be completed before the start of the 2015 season. This will involve diversion of much of the water flow in the lower park through the ponds with the introduction of 'floating islands' of vegetation for purification. A supplier has been identified and predictions of the purification that can be achieved through the three ponds are very encouraging.

Longer term solutions

An independent assessment of the feasibility of an extended outfall or diversion of the stream into the sewer network is about to be commissioned. These are viewed as the most reliable options for a predictable year on year level of quality, protecting bathing water from the adverse effects of severe weather. This is not, however, an option for 2016.

Current assessment

Both the EA and Southern Water agree that bathing water quality is improving slowly but steadily. Both agree that reasonable weather in 2015 will result in a sufficient or even a good rating for Hastings. It is vital that we complete the purification works in Alexandra Park and that Southern Water complete the 2015 programme to offset the effect of any weather problems this summer.

1) Welcome and Apologies

Keith Stevens welcomed Amanda Saunders, Kim Goodall, Michael Turner and Louise Barr, who gave a brief overview of her role, as new members of ESSP and thanked Chris Wick and Ron Francis for their contribution to the ESSP. Keith also welcomed ESSP members, delegates, observers, guests and speakers. Apologies were given and those attending on behalf of others were identified. Keith also thanked Wealden District Council for hosting ESSP at Hailsham Civic Community Hall for the meeting.

3) Notes of the meeting held on 29 April 2014 and Matters Arising

Minutes were agreed as an accurate record and actions confirmed as completed.

4) Feedback from the Open For Growth Peer Challenge

James Harris, East Sussex County Council, provided an update of the Open for Growth Peer Challenge which covered the rationale behind the Peer Challenge; the main areas of focus; the incorporation of the findings into existing strategy and next steps. He also informed ESSP Board members about how they can continue to engage in the follow up plans resulting from the Peer Challenge report. Cllr Keith Glazier emphasised the importance of continued partnership work as the action plan from the Peer Challenge is finalised and implemented.

5) Bedtime Check Campaign – Elizabeth Curtis, East Sussex Fire and Rescue Service

Elizabeth Curtis, East Sussex Fire and Rescue Service (ESFRS), gave ESSP an update on the marketing techniques and tools used to influence voluntary change in behaviour to the benefit of individuals and society. She informed ESSP that Social Marketing is being embedded at ESFRS with the aim of raising awareness of key risks among different groups of our community. She also highlighted target audiences for ESFRS, the current communication channels and some of their campaigns. Elizabeth encouraged partners to work together to send out key messages across all organisations.

6) Environment Strategy Update (requested from April meeting) – Michael Turner, Environment Agency & Andy Arnold, ESCC

Michael Turner, Environment Agency, and Andy Arnold, ESCC, updated ESSP on:

- 1) The indicators that have been adopted to measure the long-term effectiveness of the annual action plans that the ESSP approves each April;
- 2) Progress against these indicators in key areas and gave a particular focus to the issues of fuel poverty in East Sussex.

7) Transport Update – Jon Wheeler, Team Manager, Strategic Economic Infrastructure, ESCC

Jon Wheeler provided a presentation which focused on the link between transport and delivering the County Council's key priority: supporting economic growth. Jon provided an update on a range of existing Plans/Policy documents.

Jon then presented an update on a number of current projects which are currently underway including the Bexhill Hastings Link Road, North Bexhill Gateway Road and the A21 Tonbridge to Pembury improvements. Jon also discussed the recent Local Growth Deal received by the South East Local Enterprise Partnership and the funding received for East Sussex, the majority of which is for transport infrastructure.

8) Report of the Annual Assembly – Keith Stevens, Chair, ESPP

Keith Stevens gave a report on the Annual Assembly that was held in July. It was noted that feedback was positive. Keith reminded ESSP that part on the WW1 presentation encouraged people to get involved in recording information. Steve Manwaring informed the ESSP that he has worked in collaboration with Dr. Chris Kempshall, First World War Commemorations Project Officer, ESCC, to produce a story on East Sussex Soldiers that were 'shot at dawn' due to breaking or 'perceived' breaking of military laws. Steve also said that it had been really easy to collaborate with ESCC on this project and encouraged other partners to do the same. Steve also reminded ESSP members that although we could do no more for those soldiers that were shot we could all continue to help people that suffer with post-traumatic stress disorder and other mental health problems.

Keith finished the feedback by telling ESSP that there have been plenty of suggestions for next year's Assembly and it is suggested that the event focuses on Community Resilience. There was agreement for this subject.
