

Purpose of Report

Draft byelaws for Promenades and the Seashore were submitted to the Department for Communities and Local Government (DCLG) on the 24th September 2014 for provisional approval. A change in legislation has necessitated the DCLG clearing their backlog so that provisional approval is soon to be received.

Recommendation(s)

1. Council approve the making and adoption of the Byelaws for Promenades and the Byelaws for the Seashore.

Reasons for Recommendations

The Byelaw (Alternative Procedure)(England) Regulations 2016 will come into force on 3 March 2016. This means that the Byelaws need to be sealed before that date to ensure that they can follow the process under Section 236(4) Local Government Axt 1972





Introduction

- 1. A working group of the Coastal User Group was tasked with a review of the management of coastal leisure activities in 2013. It considered a range of options to try and influence behaviour and the location of certain activities including revisions to signage, pre-arrival information on the Hastings Borough Council and other websites, direct liaison with groups and clubs and also suggested a review of the current byelaws that are relevant to our promenade and seashore.
- 2. An assessment of existing byelaws confirmed they were difficult to understand for members of the public, had inappropriate levels of penalty and in some cases were no longer relevant. Discussion with the Chief Legal Officer and research with other coastal authorities revealed that it was a relatively straightforward process to review and rationalise the existing range of outdated byelaws, and to replace them with two Model Byelaws that cover the whole range activities arranged in separate Byelaws for Promenades and for the Seashore.

Consultation

- Initial internal consultation within Hastings Borough Council, with the Foreshore
 Trust as an additional landowner and through the Coastal User Group was
 undertaken in 2014 and the proposed revisions fully supported.
- 4. This was followed by extensive informal consultation with sports, leisure and other user groups and relevant local organisations. Specific copies were sent to all emergency services including Coastguard and RNLI and to local disability groups.
- 5. Wider public consultation was carried out between 05.09.14 and 26.10.14, this included full copies of the draft byelaws and maps being made available and promoted on the Council's website, Facebook page and Twitter. Hard copies were deposited in the Council's Information and Contact Centres. It was also sent by eBulletin to 800+ voluntary and community groups
- 6. The results of the consultation and our responses were sent to the Department for Communities and Local Government (DCLG) in September 2014, as part of our application for provisional approval.
- 7. Despite persistent attempts throughout the past 15 months we have not been able gain confirmation of provisional approval from the DCLG although we are now told that we should be receiving this on 19 February 2016

Timetable

- 8. We have only recently been advised that imminent changes in legislation to byelaws mean that we need to seek urgent approval from Council that they make and adopt the two Byelaws affected. If not we would have to start again from the beginning under the new provisions.
- 9. Once the decision to make and adopt the Byelaws is made they will be sealed before the 3 March 2016. Then the Council will give public notice of the Council's





intention to apply for formal confirmation of the Byelaws from the DCLG. The public notice will give the address of the DCLG in the notice so that objectors can give their comments to the DCLG. It is likely that the DCLG will confirm the Byelaws after the end of the month consultation period. The byelaws should then become effective one month afterwards unless the DCLG state an effective date for the byelaws. It is hoped that as the DCLG have given provisional confirmation they will give formal confirmation.

SCHEDULE 1 – Promenades to which byelaws apply generally

SCHEDULE 2 - Designated routes for cycling and skateboarding

Byelaws made under Section 83 of the Public Health Acts Amendment 1907 by the Hastings Borough Council for the prevention of danger, obstruction or annoyance to persons using the Esplanades or Promenades.

General Interpretation

1. In these Byelaws:

"the Council" means Hastings Borough Council

"designated" in relation to a route or area means set aside for a specified purpose, the route or area and the purpose to be indicated by notices placed in a conspicuous position.

"invalid carriage" means a vehicle, whether mechanically propelled or not,

- (a) the unladen weight of which does not exceed 150 Kilograms,
- (b) the width of which does not exceed 0.85 metres, and

which has been constructed or adapted for use for the carriage of a person suffering from a disability and used solely by such a person;

"Promenade" means Promenades described in Schedule 1

"motor vehicle" means a mechanically propelled vehicle other than an invalid carriage.

"self-propelled vehicle" means a vehicle other than a cycle, invalid carriage, or pram which is propelled by the weight or force of one or more persons skating, sliding or riding the vehicle or by one or more other persons pulling or pushing the vehicle.

Application

2. These Byelaws apply to all of the Promenades within the District of Hastings Borough Council as described in Schedule 1

Cycling

 No person shall without reasonable excuse ride a cycle on the Promenade except where there is a right of way for cycles or on the designated route as shown on Map P2 in Schedule 2.

Motor Vehicles

4. No person shall without reasonable excuse drive or bring a motor vehicle or trailer onto the Promenade except -

on any part of the Promenade where there is a right of way for that class of vehicle.

Trading

- 5. No person shall -
 - (a) sell or hawk any article or any food or any drink;
 - (b) advertise or solicit custom for any service; or
 - (c) distribute handbills, circulars or advertisements

in such a manner as to cause obstruction or annoyance to any person on the Promenade.

Skateboarding

6.

- (1) No person shall skate, slide or ride on rollers, skateboards or other self-propelled vehicles on the Promenade except where there is a right of way for cycles or on the designated route as shown on Map P2 in Schedule 2
- (2) No person shall skate, slide or ride on rollers, skateboards or other self-propelled vehicles on the Promenade in such a manner as to cause danger or give reasonable grounds for annoyance to other persons using the Promenade.

Protection of Flower Beds and Planting

- 7. No person shall walk on or ride over -
 - (a) any flower bed, shrub or plant;
 - (b) any ground in the course of preparation as a flower bed or for the growth of any tree, shrub or plant; or
 - (c) any area of the Promenade set aside by the Council for the renovation of turf or for other landscaping purposes and indicated by a notice conspicuously displayed.

Unauthorised Erection of Structures

8.

- (1) No person shall erect or place on the Promenade any booths, tents, sheds, stands, stalls, shows, exhibition, swings, roundabouts, or any other structure, whether fixed or movable, except in a designated area for such structures.
- (2) Byelaw 8(1) shall not apply to the use of personal windbreaks or sunshelters

Removal of Signs and Structures

9. No person shall without reasonable excuse remove from the Promenade or displace any barrier, post or seat or any part of any structure or ornament or any notice or flag displayed by or on behalf of the Council or any other competent authority.

Interference with Life-Saving Appliances

10. No person shall, except in case of emergency, remove from or displace any life-saving appliance provided by or on behalf of the Council or other competent authority on the Promenade.

Obstruction

- 11. No person shall on the Promenade
 - (a) obstruct any officer of the Council in the proper execution of his duties.
 - (b) obstruct any person carrying out an act which is necessary to the proper execution of a contract with the Council.

Savings

12. It shall not be an offence under these Byelaws for an officer of the Council to do anything necessary to the proper execution of his duty or for any person acting in accordance with a contract with the Council to do anything necessary to the proper execution of that contract.

Penalty

13. Every person who shall offend against any of these Byelaws shall be liable on summary conviction to a fine not exceeding level 2 on the Standard scale.

Revocation of Byelaws

14. The byelaws relating to the Parade, Stade, Foreshore and Sands which were made by the Mayor, Aldermen and Burgesses of the County Borough of Hastings on the 3rd July 1896 and confirmed by the Local Government Board on 27th August 1896 are revoked under Section 236B(2) of the Local Government Act 1972.

The byelaws relating to Selling and Hawking on the seashore or esplanades which were made by the Mayor, Aldermen and Burgesses of the Borough of Hastings on 2nd March 1906 and confirmed by the Secretary of State on 7th May 1906 are revoked under Section 236B(2) of the Local Government Act 1972.

The byelaws relating to the User of Certain Parades and Promenades which were made by the Council of the County Borough of Hastings on 11th July 1939 and confirmed by the Secretary of State on 1st October 1939 are revoked under Section 236B(2) of the Local Government Act 1972.

The byelaws relating to the Prevention of Danger, Obstruction or Annoyance to persons using the Promenades which were made by the Mayor, Aldermen and Burgesses of the County Borough of Hastings on 12th March 1964 and confirmed by the Secretary of State on 27th May 1964 are revoked under Section 236B(2) of the Local Government Act 1972.

The byelaws relating to Skateboarding which were made by the Hastings Borough Council on 3rd September 1990 and confirmed by the Secretary of State on 8th January 1991 are revoked under Section 236B(2) of the Local Government Act 1972.



Schedule 1

The Promenades and Esplanades referred to in Byelaw (2) are as follows:

The Promenade being the areas i) between the South side of the carriageway of the A259 and the beach from, in the East, an imaginary line running northwards from the Harbour Arm to the Eastern end of East Beach Street to, in the West, the junction of the A259 with Sea Road, all such area to include the footway on the South Side of the A259, the Upper and Lower Promenades incorporating Bottle Alley, Marina Car Park and Pelham Place Car Park (as shown on Maps 2a, 2b and 2c, cross-hatched in black) and ii) between the South side of the carriageway of Sea Road and the beach (As shown on Map 2d cross-hatched in black).




Schedule 2

Designated routes for cycling and skateboarding (Byelaws 3 and 6)

The designated cycling route runs along the promenade adjacent to the sea from the south side of the carriageway opposite East Beach Street, running west past East Parade, Marine Parade, Sturdee Place, Pelham Place, Breeds Place, Denmark Place, White Rock, Verulam Place, Eversfield Place, Grand Parade, Marina to Sea Road.

SCHEDULE 1 - areas of seashore to which byelaws apply

Byelaws made under Section 82 of the Public Health Acts Amendment Act 1907 by Hastings Borough Council for the prevention of danger, obstruction, or annoyance to persons using the seashore.

Interpretation

1. In these byelaws:

"the Council" means Hastings Borough Council

"designated area" means an area of the seashore which is set aside for a specified purpose, that area and purpose to be indicated by notices placed in a conspicuous position;

"seashore" means all that area of beach and foreshore including all steps, ramps, paths and jetties from time to time situated above the level of low watermark of medium tides/between the level of low watermark of medium tides and the promenade; as described in Schedule 1

Application

2. These byelaws apply to all areas of seashore that border the Borough of Hastings as set out in Schedule 1

Sandlines

3. No sandlines shall be laid in such a position as to be likely to cause injury to any person using the seashore, and all sandlines shall be visibly marked.

Public Shows and Performances

- 4.
- (1) No person shall deliver any lecture, sermon or speech or perform any music, or hold any entertainment except in a designated area for such performances.
- (2) No person shall use any designated area for performances in such a manner as to cause obstruction or annoyance to any person using it for any purpose for which it has been set apart.

Trading

- 5. No person shall;
 - (a) sell or hawk any article or any food or drink;

- (b) advertise or solicit custom for any service; or
- (c) distribute handbills, circulars or advertisements

in such a manner as to cause obstruction or annoyance to any person on the seashore.

Fires

6.

- (1) No person shall on the seashore light a fire, or place, throw or drop a lighted match or any other thing likely to cause a fire.
- (2) Byelaw 6(1) shall not apply -
 - in a designated area for barbecues, to the lighting or use in such a manner as to safeguard against damage or danger of a properly constructed camping stove or barbecue in such a manner as to safeguard against damage or danger; or
 - (ii) to the lighting of a fire on the seashore with the consent of the Council.

Parties

7.

- (1) No person shall hold a party on the seashore without the consent of the Council.
- (2) In Byelaw 7(1), "party" means an event attended by 15 or more people at which music will be played.

Unauthorised Erection of Structures

8.

- (1) No person shall erect or place on the seashore any booths, tents, sheds, stands, stalls, shows, exhibitions, swings, roundabouts, or any other structure, whether fixed or movable, except in a designated area for such structures.
- (2) Byelaw 8(1) shall not apply to the use of personal windbreaks or sunshelters.

Removal of Signs and Structures

9. No person shall without reasonable excuse remove from the seashore or displace any barrier, post or seat or any part of any structure or ornament or any notice or flag displayed by or on behalf of the Council or any other competent authority.

Interference with Life-Saving Appliances

 No person shall except in case of emergency remove from the seashore or displace any life saving appliance provided by or on behalf of the Council or any other competent authority.

Obstruction

- 11. No person shall on the seashore
 - (a) obstruct any officer of the Council in the proper execution of his duties.
 - (b) obstruct any person carrying out an act which is necessary to the proper execution of a contract with the Council.

Savings

12. It shall not be an offence under these byelaws for an officer of the Council to do anything necessary to the proper execution of his duty or for any person acting in accordance with a contract with the Council to do anything necessary to the proper execution of that contract.

Nothing in or done under these byelaws shall --

- (a) prevent the exercise of any public rights; or
- (b) affect any right, power or privilege legally exercisable by any person in, over and in respect of the foreshore.

Penalty

13. Any person offending against any of these byelaws shall be liable on summary conviction to a fine not exceeding Level 2 on the standard scale.

Revocation of Byelaws

14. The byelaws relating to the Parades, Stade, Foreshore and Sands which were made by the Mayor, Aldermen and Burgesses of the Borough of Hastings on 3rd July 1896 and confirmed by the Local Government Board on 27th August 1896 are revoked under Section 236B(2) of the Local Government Act 1972.

The byelaws relating to Selling and Hawking on the seashore or esplanades which were made by the Mayor, Aldermen and Burgesses of the Borough of Hastings on 2nd March 1906 and confirmed by the Secretary of State on 7th May 1906 are revoked under Section 236B(2) of the Local Government Act 1972.

The byelaws relating to wireless sets, gramophones, amplifiers or similar instruments on the beach which were made by the Mayor, Aldermen and Burgesses of the County Borough of Hastings on 18th April 1963 confirmed by the Secretary of State on 31st May 1963 are revoked under Section 236B(2) of the Local Government Act 1972.



BY-LAWS

RELATING TO THE

Parades, Stade, Foreshore & Sands.

The Mayor, Aldermen, and Burgesses of the Borough of Hastings, in the County of Sussex, acting by the Council under the powers of the Hastings Improvement Act, 1885, do hereby make the following By-laws for the preservation of order and good conduct among persons frequenting the Parades, Stade, Foreshore, and Sands within the said Borough, and do hereby impose the penalties and further penalties in the same By-laws mentioned.

No person shall do any of the following acts on the Parades, Stade, Foreshore, or Sands within the Borough of Hastings.

(1.) Take part in any fighting, boxing, or wrestling match, or lie, sleep, sit, stand or rest in any indecent posture.

- (2.) Carelessly or negligently injure, deface, remove, or disfigure by posting or painting, any bill, placard, or notice, on any groyne, fence, barrier, notice board, or other thing put up by the Corporation of Hastings.
- (3) Except as hereinafter provided,
- (a) erect or place on the Parades, Stade, Foreshore, or Sands, within the said Borough any Booth, Tent, Shed, Stand, Stall, Show, Exhibition, Swing, Round-about, or other similar erection, or bring thereon any van, photographic cart, or other vehicle.
- (b) give or exhibit on any part of the said Parades, Stade, Foreshore, or Sands, any performance, or delivor thereon any address, lecture, sermon, or speech, of any kind or description whatsoever, or hold or take part in any public assemblage.

Provided that nothing in this By-law shall prohibit

(a) the erection or placing of any Booth, Tent, or other such erection as aforesaid, or the bringing of any van, photographic cart, or other such vehicle as aforesaid, or

(δ) the giving or exhibiting of any performance, or the delivery of any address, lecture, sermon, or speech, or the holding of any orderly public assemblage upon such portion or portions of the Parades, Stade, Foreshore, or Sands aforesaid, which the Corporation shall from time to time, by notice affixed or set up thereon, appoint for the purpose, and subject to such conditions and such regulations as the Corporation may from time to time prescribe, and of which notice shall be given by placards posted on or near such portion or portions of the Parades, Stade, Foreshore, or Sands so appointed as aforesaid.

Sound or play upon any musical instrument or sing or make any noise whatsoever on any part of the Parades, Stade, Foreshore, or Sands within the said Borough, so as to be or occasion any nuisance or annoyance, or disturbance, to any householder resident in any house near to or adjoining such Parades, Stade, Foreshore, or Sands, and after having been requested by such householder, or by any Police Constable to desist from making such.

noise or noises, either on account of illness of any inmate of such house, or for any reasonable cause.

Penullies.

Every person who shall offend against any provision of the foregoing By-laws shall be liable for every such offence to a penalty of FIVE POUNDS, and for every continuing offence to a further penalty of Forty Shillings for each day on which the offence continuing after written notice thereof shall have been given to him by the Council. Provided nevertheless that the Justices or Court, before whom any complaint may be made or any proceedings may be taken in respect of any such offence may, if they think fit, adjudge the payment as a penalty of any sum less than the full amount of the penalty hereby imposed.

Provided further that an officer or servant of the Council or a person duly authorised by the Council in writing under the hand of the Town Clerk shall not be liable to any penalty in respect of any act done by such officer, servant, or person within the scope of his employment, or in pursuance of the authority so conferred upon him.

Saving for rights of Crown.

Provided nothing in these By-laws contained shall in any way prejudice Hor Majesty,

Her heirs and successors or Her or their tenants or lessees of foreshore belonging to Her or them, in the use, occupation, and enjoyment of any such foreshore.

The common Scal of the Mayor, Aldermen, and Burgesses, of the Borough of Hustings, was affixed to the By-laws hereinbefore conditioned on the 3rd day of July, 1896, in pursuance of an order made at a Meeting of the Council of the said Borough held on the said presence of presence of



BYELAW

for the good rule and government of the County Borough of Hastings and for the prevention of nuisances made by the Mayor Aldermen and Burgesses of the County Borough of Hastings acting by the Council under Section 249 of the Local Government Act 1933.

1. ANY person who by operating or causing or suffering to be operated any wireless set gramophone amplifier or similar instrument on any part of the beach (which expression shall include the sands) above or below highwater mark to which the public are admitted within the County Borough of Hastings makes or causes or suffers to be made any noise which is so loud and so continuous or repeated as to give reasonable cause for annoyance to other persons shall be guilty of an offence.

PROVIDED that this byelaw shall not apply to any wireless set gramophone amplifier or similar instrument

- (a) Used by a police constable in the execution of his duty.
- (b) Used by the Fire Brigade or ambulance services.
- (c) Used by the said Council.
- (d) Used for communication with persons on a vessel for the purpose of directing the movement of that or any other vessel.
- (e) Used in case of emergency.

- 2. ANY person offending against this byelaw shall be liable on summary conviction to a fine not exceeding £5.
- 3. FROM and after the date of the confirmation of this byelaw the byelaw for good rule and government of the County Borough of Hastings and for the prevention of nuisances made by the Council of the County Borough of Hastings on the 16th day of March, 1935, and confirmed by the Secretary of State on the 13th day of June, 1935, is hereby revoked in so far as it applies to the beach (which expression shall include the sands) above or below highwater mark to which the public are admitted within the said County Borough of Hastings.
