**Report Title:** Application for a premises licence with representations. Stade Hall.

#### Purpose of Report

To consider the application for a new premises licence as a result of representations received. Interested Parties, One.

#### Recommendation(s)

1. Members consider the content of the report, the options available and reach a decision.

#### **Reasons for Recommendations**

The Licensing Act 2003 requires a licensing sub committee to consider such applications when appropriate representations have been made. The decision reached at the sub committee can be subject to appeal by any party to the hearing who is agreived by the decision.



# Introduction

## 1.0 Background History

- 1. On 7th February 2005 the Licensing Act 2003 came into force for all local authorities, marking the practical commencement of the Government's new liquor licensing regime.
- 2. The Act also changed the definition of a premise to its widest possible meaning, in other words, anywhere. Therefore any place that wishes to hold an event that incorporates all or some of the following activities will require a premise licence. The activities being the sale by retail of alcohol, the provision of regulated entertainment and the provision of late night refreshment.
- 3. On the 7th July 2011 Hastings Borough Council Licensing Authority received an application for a new premises licence at the new Stade Hall, The Stade, Hastings from Hastings Borough Council Communications and Marketing Department, made under section 17 the Licensing Act 2003. (Attached at appendix A).
- 4. The Stade Hall is a new community facility sited adjacent to the new Stade Open space and the site of the Jerwood Art Gallery, Hastings. (Map attached at appendix B.)
- 5. The premise does not currently hold a premises licence under the Licensing Act 2003.

## 2.0 Application

- 6. The application requests the following:
- 7. To have performance of plays, films, indoor sporting events, live music, recorded music, performance of dance, entertainment of a similar description on Monday to Saturday from 09.00hrs to 24.00 hrs and Sunday 09.00hrs to 23.00hrs.
- 8. To have the provision of facilities for making music, dancing and entertainment of a similar description on Monday to Saturday from 09.00 hrs to 24.00hrs and Sunday from 09.00 hrs to 23.00 hrs.
- 9. To have Late Night Refreshment on Monday to Saturday from 23.00hrs to 24.00hrs
- 10. To have supply of alcohol for both "On and Off" sales on Monday to Sunday from 09.00hrs to 23.00hrs.
- 11. The hours the premises are open to the public are proposed to be Monday to Saturday 08.00hrs to 24.00hrs and Sunday 08.00hrs to 23.30hrs.
- 12. When submitting an application for a licence under the Licensing Act 2003 the applicant is asked to describe what steps they intend to take to promote the four licensing objectives:-





- the prevention of crime and disorder,
- public safety,
- prevention of public nuisance,
- protection of children from harm.
- 13. In this case the applicant has made a full declaration, this is shown on Pages 20 to 21 of the application.(See appendix A)

# 3.0 Consultation

- 14. The Licensing Act 2003 requires an applicant to advertise their application once in a local newspaper and on the premises by way of an approved notice for 28 days to allow for representations to be made, this has been done.
- 15. Copies of the application are required to be served on a list of responsible authorities at the same time as placing the application before the local authority, this has been done.
- 16. As a result of this process one representation has been received from Mr Edwards on behalf of the Hastings Old Town Residents Association, he comments on the concerns of the association in respect of the hours requested for Alcohol sales and the problems anticipated as a result. I consider this to be valid representation under the licensing objective (Prevention of Crime and Disorder). (Attached appendix C).
- 17. A further report has been received from Sussex Police, they have no intrinsic objection to the application, but seek a series of conditions added to any licence issued. Those conditions have already been agreed with the applicant and are attached for information and consideration by the sub committee. (Attached appendix D)

# 4.0 Legal Considerations

- 18. The Licensing Act 2003 is now the only legislation that allows premises to be licensed for either the sale of Alcohol or the supply of regulated entertainment.
- 19. If a relevant representation to an application is made by either a responsible authority or an interested party and no compromise can be reached between the parties, a hearing must be held.
- 20. The Department for Culture, Media and Sport has issued guidance under Section 182 of the Licensing Act 2003. This guidance is provided to Licensing Authorities to assist them in carrying out their functions.
- 21. All members of the Licensing Committee have been supplied with copies of the DCMS Government guidance and the Hastings Borough Council Statement of Licensing Policy.
- 22. Human rights considerations must be taken into account fully in balancing licensing issues, in particular, article 1 of the first protocol and article 8. Article 1 relates to the protection of property and the peaceful enjoyment of possessions and property. Holding a justices licence would be considered a possession. Article 8 relates to



the right to respect for private and family life, home and correspondence. These are however qualified rights and can be deprived of "in the public interest". Interference is permissible if what is done:-

- 23. Has its basis in law;
- 24. Is necessary in a democratic society to fulfil a pressing need or pursue a legitimate aim;
- 25. Is proportionate to the aims being pursued; and,
- 26. Is related to the prevention of crime; or, the protection of public order or health.
- 27. If members chose to refuse the application in full or in part, the applicant has a right of appeal to the Magistrates' Court. There is also a right of appeal to conditions imposed as a result of the hearing.

## 5.0 Options

- 28. Grant the application in full
- 29. Grant part of the variation application
- 30. Grant the application with conditions relevant to the application
- 31. Refuse the application.

Members are reminded they must give written reasons for their decision.
