Annex 1 – Mandatory Conditions

- 1) If this premises licence authorises the supply/sale of alcohol, the following two conditions apply:
 - (i) No supply of alcohol may be made under the premises licence at a time when there is no designated premises supervisor in respect of the premises licence, or at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
 - (ii) Every supply/sale of alcohol under the premises licence must be made or authorised by a person who holds a personal licence

- 2) If this premises licence authorises the exhibition of films the admission of children to the exhibition of any film must be restricted in accordance with this section.

Hastings Borough Council will expect the age restrictions of the British Board of Film Classification (BBFC) or authority designated under Section 4 of the Video Recordings Act 1984 to be complied with. Only in exceptional cases will variations of this general rule be granted by the Council and then only with the appropriate safeguards

- 3) If this premises licence includes a condition that at specified times one or more individuals must be at the premises to carry out a security activity (as defined by the Private Security Industry Act 2001) then such individuals must be licensed by the Security Industry Authority.

Annex 2 – Conditions consistent with the operating schedule

General

To comply with the decision of the licensing sub committee, as detailed in full in Annex 3.

To ensure that a written record of staff training is kept (licensing sub committee decision).

To ensure that a written record of authorisation to sell alcohol is maintained for each staff member (licensing sub committee decision).

The prevention of crime & disorder

To ensure that there are two members of staff on duty at all times.

To ensure the CCTV system installed is operational during trading hours.

To ensure the CCTV system is maintained.

To ensure the CCTV recorded images are retained for a period of 31 days and images are made available to the police and licensing authority when required. **(Amended by consent on the variation application)**

Public safety

To ensure the fire precautions and fire extinguishers are checked regularly and serviced annually.

To ensure that two members of staff over the age of 18yrs to be present in the shop at all times from 7pm to closing time on Thursday, Friday and Saturday nights. (Variation amendment by consent)

The prevention of public nuisance

To liaise with neighbours on a regular basis regarding any noise complaints.

The protection of children from harm

To ensure that a record of refusals to sell alcohol is kept at the premises and that document is regularly reviewed by the Designated Premises Supervisor (Licensing sub committee decision).

To ensure that the premises implements a Challenge Under 21 policy & advertises that policy by displaying signage in prominent and visible positions both at the till and around the store. (Licensing sub committee decision).(Amended by consent).

To ensure that proof of age is confirmed by PASS approved proof of age cards, Passport or Photo Driving Licence (Licensing sub committee decision)

6. that the proof of age is confirmed by PASS approved proof of age cards, Passport or Photo Driving Licence.
