**Statement in support of Variation of premises licence.**

In respect of the enclosed application I would like to draw your attention to the following.

Having been the licensee for the North Star Inn for the past two and a half years where I have established a safe, friendly and busy environment, I was approached by Enterprise Inns to take over the licence for the General Havelock. Following much consultation and soul searching I agreed and between us we spent in excess of £130,000 to transform the pub and to change its name and image in order to create a safe and mature establishment in the centre of town.

The pub has now been open for approximately two months and the initial feedback is encouraging however the constraints of the current licence arrangements make it difficult to function in a competitive environment and to establish a good solid customer base.

I fully understand the difficulties experienced in the past but do not wish to be judged by another person's mistakes, I fully understand your concerns of this public house in a central saturation zone and all of the difficulties that it presents.


I am however happy to work with you to alleviate these concerns, to that end I have established an over 18's only establishment and would be happy to extend that to over 21's, should the variations be agreed.

I have just paid for two of the senior staff to sit their personal licences and have established a system of continuous training in areas like drugs awareness, handling aggression etc.

I am happy to maintain some of the conditions ie; two door supervisors, keeping one entrance closed and the DPS on site during busy times.

In conclusion I would rather be judged by my successes rather than the failures of the previous licensee and feel sure that I can establish a calm, safe and mature adult environment for the over 21's who wish to use the town centre during the weekends.

Dear Trevor, many thanks for your observations and your offer to circulate this revision of the points you raised.

I am fully aware of the implications of being in the middle of a saturation/cumulative impact policy area and hope that this will satisfy any concerned parties, I once again state my intention in working together with all agencies concerned to ensure the four licensing objectives are met and to create a safe, clean environment for people to enjoy themselves at The General Havelock.

In relation to **Prevention of crime and disorder** I have installed CCTV, employed door staff, and have started a programme of continuous professional training for bar staff.

In relation to **Public Safety**, I have asked door staff to ensure that the fire risk assessment's recommendation of a max 80 customers be strictly adhered to, that staff are adequately trained, and that a personal license holder be present at weekends and bank holidays.

In relation to **Prevention of public nuisance** I have installed a physical barrier to my trading area with adequate, specially designed furniture, no drinks will be allowed outside this area at any time and no drinks will be allowed in the outside seating/smoking area after 23.00, Windows and doors to be closed during any music events and staff to monitor and maintain reasonable volume levels at all times, door staff to monitor.

In relation to the **Protection of children from harm**, I currently do not allow under 18's on the premises at any time and will not allow under 21's under this variation.

I am asking to change the hours of door staff as follows, 1 starting at 21.00 and one at 22.00 both to remain on site until close.

Can I confirm that all sales of alcohol will stop at 02.00 allowing a half hour drinking up time, leaving those who wish to continue socialising many options locally until 03.00 or 04.00.
