The premises was formerly a licensed public house (the Smugglers) which ceased trading some years ago. The premises was purchased by the applicants in (17/12/ 2010). This variation is to amend the existing premises licence in the following as a licensed restaurant:-

- A new layout to the ground floor restaurant area;
- A new layout to the first floor with its extension as use as an additional area of the licensed restaurant.

- Adding Late Night refreshment Monday to Sunday 23.00 to 02.00 hours for diners eating in and takeaway service.

- This premises is going to be a Restaurant & Bar on the ground floor and first floor.
- The whole building has been refurbished.
- The main toilet facilities have been provided on the first floor as well as one toilet facility being provided on the ground floor.
- There will be two bars, one on each floor (ground & first floor) alcohol will be served.
- The ground, first & second floors have the benefit of a rear extensions.
- There will be a walk on flat roof area on the second floor inclusive of retaining walls.
- The requisite stair cases have been inclusive of the refurbishments and fire escape notices.
- The whole premises have been re-wired with the inclusion of a three phase electric service.
- The gas service has been renewed.
- The shop front has been replaced & the external signage has been replaced
- There is also one flat above on the second & third floor.
- The flat will include bathroom, lounge& bed room facilities.
- The third floor flat will include one kitchen.


