14. MUSEUM ATTENDANCE AND WEBSITE FIGURES

Attendances at the main Museum and Art Gallery were still holding up well after the reopening last year and were the highest for this quarter since they were first reported as performance indicators in 2001.

Visitors to the Old Town Hall had been slowly increasing since a drop in 2005.

The rise in website hits was impressive and had more than trebled since first recorded in 2004.

Educational visits were slightly lower than comparable periods in earlier years. The Museum had been concentrating on outreach and family activities.

15. MUSEUM EVENTS

Victoria Williams, Museum Curator, presented a report to inform members of forthcoming exhibitions including:

- Re-hang of the Long Gallery A display of historic pictures showing the interior of local buildings including shops, theatres and churches.
- The Roger Woods Design Archive An exhibition featuring the textile designs of local designer Roger Woods.
- Bedouin Jewellery A small exhibition of Bedouin jewellery from Saudi Arabia.
- Turner and Bonington A large scale touring exhibition focusing on early 19th Century works by JMW Turner and Richard Parkes Bonington comparing images of the coast on the English and French sides of the Channel.

Forthcoming educational activities included:

- Discover...Family activity workshops On the first Saturday of every month (except January) family groups will be invited to enjoy a range of activities led by artists and Museum staff.
- Teachers' Inset Day Focussing on Science and Maths in connection with the European Baskets exhibition.

Councillor Webb asked that the History of the Old Town Hall exhibition, celebrating its 50 years as a Museum be an agenda item for the next meeting.

16. LOANS

Victoria Williams, Museum Curator, presented a report to update Members on loans from the Museum collection.

The Dulwich Picture Gallery was borrowing the Museum's portrait of Signor de Rossi by Walter Sickert of 1901 for an exhibition entitled 'Sickert in Venice' which would run from 4th March to 31st May 2009. The loan was subject to satisfactory insurance, transportation, security and environmental arrangements.

The second item on loan was the Hawaiian feathered cloak. This had been loaned to the Musee du Quai Branly in France. It went on loan at the end of June 2008, was transported well but a week into the exhibition the mount became detached from the wall and the cloak was discovered lying at the base of the display case. Victoria and a conservator visited the French Museum to examine the cloak and found no permanent damage, only creasing. When the cloak returns to the UK, it would be sent to a conservator. All costs incurred would be covered by the Musee du Quai Branly.

The Museum Curator, Victoria Williams, presented the above report to provide an update on progress regarding the mounting of commemorative plaques.
