Background

1. Horntye photographs

As requested by the Committee the Museum purchased a selection of Horntye cricket memorabilia at Knights auction in Leicester on 19th July. In consultation with Cllr Finch, instructions were given to cricket history specialist, Nick Sharp to bid on our behalf and the following items were acquired:

Team photograph in front of the pavillion, Central Cricket Ground, North v. South 1888 Team photograph by the pavillion, Gentlemen v. Players, 1894
Team photograph by the pavillion, Hastings and St Leonards Cricket Club 1900
View of the Central Cricket Ground with a match in progress c.1890
Studio portrait of Tom Parkin in cricket clothes
(3 of the photographs include W.G.Grace.)



The total cost of the five lots with commission and VAT was £1,391 which will be covered by the Brassey Fund.

The photographs are a representative sample of the club's archive and it is felt that the cost was appropriate in view of future calls on the Museum's purchase funds.
