## Purpose of Report

to provide an update to members on the proposals in the Draft Corporate Plan and Budget and to make recommendation to Cabinet on which day to close the Museum and Art Gallery.

## Recommendation(s)

1. That Museums Committee recommend that Hastings Museum and Art Gallery closes to the public on Mondays

## Reasons for Recommendations

## Introduction

Hastings Borough Council has now published its draft Corporate Plan, and
Efficiencies, Income and Savings Proposals for 2011/12 and 2012/13. All comments on the proposals will be considered by the Cabinet on 16 February,

The Full Council will receive recommendations from the Cabinet and will make the final decisions on the Corporate Plan and Budget on 28 February.

## Corporate Plan

The Council's Corporate Plan sets out the targets we will be working to achieve during 2011/12. For the Museum this is:

Provide an exhibition and education programme for visitors to our Museums. Develop proposals for their long-term sustainability in light of financial constraints.

Measures:

- Visitor targets achieved.
- Proposals for management of Old Town Hall Museum developed.


## Budget Proposals

The two proposals which affect the Museum service are:

- Close the Museum and Art Gallery one day a week - the Museum's Committee to advise which day
- Reduce the operating budget for temporary exhibitions and education

It is hoped that closing the Museum for one day a week will save approximately $£ 10,000$ per annum. This saving can be achieved by altering staff working patterns to reduce reliance on casual staff.

Research from other local Museums suggests that the most popular days for closing are Sunday and Monday.

A brief analysis has also been made of visitor figures to the Museum on the two days in question. In 2010 there were a total of 3,276 visitors to the Museum on Sundays and 4,745 on Mondays. The figure for Mondays includes 1,372 who visited as part of an educational group.

Although the pattern is of more visitors on Mondays, it is recommended that this is the day that the Museum closes. It is hoped that the educational visits, mostly Foreign Language Schools, will be able to change the day they come. Sunday is the only day available for leisure visits for many people and is also becoming a popular day for wedding ceremonies.

It is also suggested that the Museums' opening times on Sunday are reduced by one hour to 12-5, instead of 11-5. This further reduces reliance on casual staff to cover the lunch-time period
