Introduction

1. Background

A review of current service provision at the Old Town Hall Museum was initially proposed to consider the impact of the operation of the Tourist Information Centre. In recognition of possible future budget reductions the review has been widened to look at options for the future delivery of all services at the Old Town Hall Museum.

2. Results of Survey

A questionnaire was sent to 500 members of the Museum Association, other local societies and to all schools in Hastings and St Leonards. Copies were also available for the public visiting both of the Museum sites.

A total of 40 questionnaires were returned. The main results are as follows:

The 5 most important services offered at the Old Town Hall Museum.

- 1. Permanent displays on history of the Old Town
- 2. Fully accessible building
- 3. Museum Shop
- 4. Information and leaflets for tourists
- 5. Archive Film footage

The 5 least important services offered at the Old Town Hall Museum

- 1. Railway tickets
- 2. Accommodation booking
- 3. East Sussex County Council information kiosk
- 4. Vegetable bag collection point
- 5. Toilet facilities

The 5 most important services to be in an Old Town location

- 1. Permanent displays on history of the Old Town
- 2. Fully accessible building
- 3. Information and leaflets for tourists
- 4. Museum shop
- 5. Archive film footage

The 5 least important services to be in an Old Town location

- 1. Vegetable bag collection point
- 2. Railway tickets
- 3. East Sussex County Council information kiosk
- 4. Accommodation booking
- 5. Toilet facilities
