Purpose of Report

Background

Introduction

- 1. The Council meeting on 23rd February 2009 agreed parts I and II of the Corporate Plan 2009/10 to 2011/12– these documents set out the Council's strategic direction, 3-year goals and work-plans for 2009/10.
- 2. Part III of the Corporate Plan contains a report back against the milestones and targets set out in Part II of the Corporate Plan relating to 2008/09 and will set out the performance indicator targets for the next three years.
- 3. The 15th June Cabinet has been given delegated authority by the Council to agree Part III of the Corporate Plan prior to publication by 30th June.

Retrospective Performance Report Back – Appendix A

- 4. Appendix A provides a report back on performance during 2008/09 against the Corporate Plan targets for the Directorate and Services relevant to this committee.
- 5. The narrative accompanying the target explains whether the target has been Achieved or is the subject of a Shortfall in performance or been impacted by a Change in circumstances which meant that it was no longer reasonable/possible to achieve the original target. For areas of shortfall, explanations are given as to what action will be taken to improve performance, and these shortfalls will be carried over into performance monitoring during 2009/10.

- 6. Appendix B reports on year-end performance against the indicators set out in the Corporate Plan, which O & S have been monitoring during the year.
- 7. The tables in appendix detail performance against targets for 2008/09 for all Performance Indicators for Directorates relevant to this Committee as well as targets for 2009/10 -2011/12.

Financial Position

8. Work is ongoing to finalise the Council's year-end position in respect of both revenue and capital expenditure. The Audit Committee will consider a comprehensive report on the final position in June. Based on provisional figures no overall overspend on either the Revenue Account or the Capital Programme is anticipated.
