Background

Cabinet Meeting held on 13 September 2010

34. NON DOMESTIC RATE RELIEF: CHARITIES, COMMUNITY AMATEUR SPORTS CLUBS (CASCs) AND OTHER ORGANISATIONS

Decision:

- (1) 20% discretionary relief be granted, in addition to the 80% mandatory relief, for charities in respect of 2010/11 for the 110 cases as listed in Appendix 1 to the report;
- (2) 20% discretionary relief be granted, in addition to the 80% mandatory relief, for CASCs in respect of 2010/11 for the 5 cases as listed in Appendix 2 to the report;
- (3) 100% discretionary relief be granted to the other organisations for 2010/11 in respect of the 15 cases as listed at Appendix 3 to the report;
- (4) the sum of £313.61 be remitted under Section 49 of the Local Government Act 1988 in respect of Hastings Area Community Transport;
- (5) future decisions be delegated to the Chief Executive (or nominee) in accordance with the guidance set out in the report; and
- (6) a further review be undertaken as part of the budget process.

44. TREASURY MANAGEMENT – MID YEAR REPORT 2010-11

Decision:

that the Deputy Chief Executive in consultation with the Leader of the Council be given authority to bring back in house the monies currently in place with Fund Managers, following a review of the Treasury Management Practices.

The reason for this decision was:

The Code of Practice on Treasury Management required, as a minimum, a mid-year review of Treasury Management Strategy and performance. This was intended to highlight any areas of concern that had arisen since the original strategy was approved (15 February 2010).

The investment returns achieved by the Council's fund manager in the year to date were significantly lower than that budgeted for. It was the intention to review the position with the fund manager and if significant returns could not be anticipated for the next 12 months, to then manage investments in-house.

The Audit Committee on the 27 September, as delegated by Council, scrutinised the Treasury Management activities for the year to date and made the following recommendation to Cabinet:-

"The Audit Committee recommend to Cabinet they consider bringing managed funds back in house subject to appropriate safeguards being in place by revised Treasury Management Practice Statements".
