Appendix C: New National Indicators and review of existing Performance Indicators

1.0 Introduction

- 1.1 From April 2008 a new set of 198 National Indicators (NIs) will replace the current Best Value Performance Indicators (BVPIs). They will apply to all local services (police, health, local authorities) and be the "*only set of indicators that performance of local services will be assessed against by Central Government*".
- 1.2 The indicators have been developed following the publication of the Government's Comprehensive Spending Review (CSR 07) last autumn. The purpose of NIs is to manage performance against the priorities set out in the review. The 198 NIs represent a significant reduction from the1,000+ indicators the public sector were previously required to report. This reduction in numbers represents Government's efforts to reduce the central reporting burden in order to allow greater focus on local priorities.
- 1.3 Although a few of the new NIs replace existing BVPIs the new set has a greater focus on outcomes for local residents than on satisfactory service provision. Some of the new indicators will require more coordinated work across the Council or with partners to deliver than was the case for BVPIs.
- 1.4 The Department for Communities and Local Government conducted a sixweek consultation on the new indicators before Christmas. The final technical details about calculating 138 of the indicators were published at the end of February; the details for the remaining 60 indicators will be published at the end of March.

2.0 NPIs relevant to Hastings Borough Council

- 2.1 Of the 198 indicators around 60 70 relate to the District/Borough Councils (the final number will not be known until the full set is published), and performance on these will be assessed annually. (Please also see 3.5)
- 2.2 The new Local Area Agreements (LAA) will include up to 35 indicators from the new set as well as statutory education indicators from 2008/09 onwards. The new East Sussex LAA is currently being developed and will include the most appropriate indicators for our area in negotiation with the Government Office for the South East (GOSE).

3.0 Review of Existing Indicators

- 3.1 Officers have undertaken a review of our current BVPIs to identify which ones we would want to keep reporting locally, and whether to revise any of our current Local Performance Indicators.
- 3.2 Part III of the Council's Corporate Plan needs to be developed and agreed by 30th June 2008. Part III will contain a report back on performance in 2007/08 and will identify the three-year performance targets for 2008/09 2010/11. Therefore it is important to gain O & S views about which indicators should be

kept as local indicators to complement the smaller number of National Performance Indicators.

- 3.3 Once the list of new Local Indicators is finalised, targets will be set, informed by 2007/08 year-end performance, and the final list and targets will be subject to consultation with O & S and approval by Cabinet on 9th June 2008.
- 3.4 Heads of Service's proposals for indicators to keep, change or remove are listed below, identifying reasons for the changes suggested. Where a BVPI is felt to be of use and is indicated to keep, it is proposed to adopt it as a local indicator.
- 3.5 Communities and Local Government Department have produced a list of all indicators for Districts, which is included at the end. This includes some indicators such as mortality levels that they have stated that performance will be judged on at District level. It has not been made clear what the mechanism for judging performance will be, or which organisations will be involved yet, and more information is expected to follow on this.

Community Wellbeing

Significant issues relating to new or existing indicators:

NI 187 Tackling Fuel poverty - the methodology published in the consultation document for this indicator may have cost implications for collection. It will not be clear until the final publication of the indicators by April 2008 exactly what the extent of these implications may be though.

Following the successful reduction in the length placements in bed and breakfast accommodation, the new Government focus is on reducing use of all types of temporary accommodation, as reflected in its new National Indicators. In line with this we intend to drop this indicator, but will still report length of stay of families in B&B accommodation.

- L187 Number of licensed Houses in Multiple Occupation We keep a public record of licensed properties, as required by legislation. From next year this will be removed as a performance indicator though.
- L190 Homes with Disabled Facilities Grant (DFG) adaptations The amount of work we undertake for this area is determined by the level of funding available, and delivery is managed through our budget processes. From next year this will therefore be removed as a performance indicator.

L337 Improve community safety in priority neighbourhoods (Super Output Areas) through the Secure Accommodation Scheme

This indicator related to work commissioned by Neighbourhood Renewal, which has now been achieved. The indicator will therefore be removed from the end of the year.

BV225 Victims of Domestic Violence

This indicator consisted of a checklist of items to improve services in this area, all of which will have been completed by the end of the year. It is therefore proposed that it be removed from then. Incidence of domestic violence is a new National Indicator that will continue to be reported, as listed under Regeneration and Community Services.

Regeneration & Planning

Significant issues relating to new or existing indicators:

While some of the changes proposed below are relatively straightforward, and relate only to individual services, other areas may need consideration by wider services or partners. Issues that may need further consideration are indicated here.

Racial Incident Reporting

There were two indicators relating to reporting of Racial Incidents that the Council is responsible for, which are not included in the new national set. With the removal of the requirement to report these, the decision as to what information is most useful for this area for the Council should be informed by discussion at corporate level.

Speed of processing Planning Applications

The changes in grant allocation through the Planning Delivery Grant mean that there will be less resources and flexibility available within this area, which will have an effect on performance. Target performance levels will need to be reviewed in light of this.

Improvements to derelict or run down buildings

The focus for improvements over the next years will be on buildings requiring more input and time to achieve. Work is scheduled for 2008/09 to deliver a significant improvement project at Pelham, with which it should be possible to achieve the current target of 30 during the year. Targets for future years may need to be reduced to reflect the amount of work needed to achieve the improvements, and the resources of the service.

Economic Indicators

The new national indicator set includes a number of economic indicators that will be calculated by national agencies, but performance will be judged at local level. When the final set is published it will be necessary to review the existing economic indicators to ensure best alignment. The existing Community Strategy and national indicators proposed for reporting at District and County level are listed under Regeneration below.
