New local indicators for Council funded Leisure Centres have been introduced from this year. The Primetime sessions have been developed and enhanced in 2007/08, and the GP referral scheme was re-launched, which is the reason that higher figures are expected for 2008/09 and beyond. Customer satisfaction surveys are being introduced from 2008/09. There is therefore no information for 2007/08, and targets for future years will be set once the first year's data is available.

NI 008 is measured by a national survey undertaken by Sport England, and reports the percentage of people surveyed in the local authority area who are active on a regular basis. This indicator will be included in the East Sussex Local Area Agreement for 2008/09 - 10/11, and the targets shown are subject to final agreement in the LAA. The target agreed in the LAA will be for the County as a whole, and these figures are for Hastings' part in the overall target.
