# **Background**

# Cabinet Meeting held on 2 November 2009

(1) Item: Sustainable Community Strategy – key targets refresh update

#### **Decision:**

- (1) the Community Strategy Steering Group, Thematic Partnerships and Local Strategic Partnership (LSP) be thanked for their contributions to the refresh process;
- (2) the proposed Sustainable Community Strategy targets for 2010/11 and 2012/13 be agreed as set out in appendix A under authority delegated by the Council on 29th July 2009; and
- (3) the outstanding targets be brought to the next meeting of the LSP and Cabinet for consideration and approval.

- (2) Item: Stade Improvements impact on coach and car parking Decision:
- (1) Cabinet acknowledges that, properly managed, the impact of the proposed changes on the town's coach business would be minimal; and
- (2) Cabinet notes that the Stade improvements were expected to generate 112 net new jobs, and some additional £9.5m spend per annum for the local economy. It believes that the scheme will bring significant economic benefits to Hastings and the sub-region, especially, but not confined to, the Old Town.

(3) Item: Response of Hastings Borough Council to East Sussex County Council's proposal for two new academies in Hastings



- (1) Cabinet considers that the regeneration of Hastings will be impaired if the performance of all its schools does not continue to improve. It therefore awaits with interest the results of the formal consultations on the closure of the three secondary schools and their replacement by two academies. Educational attainment is seen by Hastings Borough Council as key to the continuing regeneration and prosperity of the town. The continued support for the remaining two state secondary schools in the area must be enhanced to provide genuine choice to parents and students in the town and to contribute to the regeneration of the town;
- (2) should the Academy proposals be taken forward the Academy sponsors are asked to ensure that the Borough Council and other stakeholders are positively engaged in the process of developing the educational and pastoral offer which will underpin the new Academies and in regularly monitoring their progress; and
- (3) similarly Cabinet urges the sponsors to ensure the widest involvement of parents, students, the community and partners in the governance of the Academies.

- (9) the system should be trialled for six months, with a review after the 2010 Borough elections.

## Cabinet Meeting held on 13 July 2009

(1) Item: Sustainable Communities Act Proposals

- (1) proposers, organisations and Panel members be thanked for their contributions;
- (2) submission of Proposal No. 3 to request the Government to enact legislation to enable the transfer of Highway Authority powers to District Councils in respect of on street parking as set out in paragraph 22 of the report be approved and that the other proposals be further discussed over the next 12 months; and

(2) Item: Hastings and Bexhill Economic Development And Inclusion Strategy

#### **Decision:**

- (1) the strategy be adopted as appended to the report;
- (2) authority be delegated to the Chief Executive or his nominee to make any further minor amendments to the Strategy; and
- (3) an implementation plan be brought forward to a future Cabinet meeting following consideration by the Hastings and Bexhill Economic Alliance.

(3) Item: Kent Route Utilisation Strategy Draft for Consultation

- (1) Hastings Borough Council formally responds to Network Rail's Kent Route Utilisation Strategy Draft for Consultation objecting in the strongest possible terms to the proposed withdrawal of all direct trains between Hastings and Cannon Street from 2015, and to the suggestion that peak trains between Hastings and Charing Cross be reduced from twelve coaches to eight from that date;
- (2) Hastings Borough Council works with other local authorities, MPs and opinion-formers, including the Task Force and the A21 Reference Group, representing those stations on the Hastings line (Frant and south thereof) likely to be affected, to galvanise opposition to the proposed train cuts; and
- (3) Hastings Borough Council seeks an urgent meeting with Lord Adonis, Secretary of State for Transport, to emphasise the importance of the area's peak service to/from London, and the effect on the local economy if this service is worsened. This is in the context of the better train service being offered from elsewhere in the south-east, especially the high-speed domestic services scheduled to operate between St Pancras



International and Kent from December 2009. Other interested partners from East Sussex (e.g. as identified in Resolution 2) be invited to join the meeting.
