Two smart working workshops were held in November and December and were over subscribed. They generated considerable interest amongst staff present and numerous ideas for changing the way staff work to improve efficiency and work/life balance. Demand is such that further workshops are being considered for the New Year.

Increasing hot desking and mobile/home working is likely to result in the Leisure Team being able to move from Renaissance House to Aquila House and re-join their colleagues in the Resorts and Amenities Teams which in itself will also increase the scope for more efficient working.

Work continues with the development of IT solutions to enhance the scope for home/mobile working in Housing Services and other teams.

Qtr 3 Update - On target

Progress: Planning permission for the whole scheme (the Jerwood Foundation's application for the gallery, and Hastings Borough Council's application for the quality open space, community facilities and café) was granted by Planning Committee in December, and demolition consent was granted for Tom's Cabin.

A land swap involving the Foreshore Trust and HBC is required to allow the Jerwood Gallery scheme to meet its deadlines, and preparatory work for that was completed during this period. (The land swap consultation was launched on 8th January).

Detailed contract preparation has also continued this quarter, the Highways contract is due to be let before the end of January and the contract for the rest of the HBC-led work in March. Highways work is due to start in early February, and construction work proper is still on target to start immediately after Easter.

The Stade Cultural Facilities Group (working title!), the not for profit group set up to manage the community facilities and open space, is now developing its business plan.

A bid for funding to Arts Council England in respect of the site has also been submitted this period.

9. Public Realm & Town Centres

Progress:	Designs and locations for new wayfinding signage have been submitted to the Planners for pre- application consultation. Their concerns are leading to some modifications before submission of the planning application. The Butler's Gap installation has also experienced delays during the manufacturing process but is scheduled now for March delivery. Wellington Square lights will be delivered on 25th January. The cross-cutting group will consider proposals for the 10-11 capital budget at their meeting in January.
