<p>2006 EU Bathing Directive and its impact on Hastings</p>	<p>Councillor MJ Lock submitted, "my suggestion is to review how the new 2006 EU Bathing Directive (which replaces the original 1976 Bathing Directive) could impact Hastings when it comes into effect at the end of 2014. From this I would hope to take forward measures that the council, working alongside the local water authority board and other organisations, can take to ensure we meet this more stringent standard. Clearly the quality of our beach water is of high importance to Hastings as we rely to a significant degree on the tourism sector. In fact, this could be an opportunity to look at how we could take the next step and obtain a Blue Flag status as these two measures of beach excellence and water quality involve safety, environmental education and other services.
