4. The Cabinet portfolio holder with responsibility for Hastings Country Park is ex officio Chair of the Forum.
5. A Vice-Chair needs to be appointed from amongst the membership of the Forum to act in the absence of the Chair.
6. Urgency - There is a Country Park Management Forum meeting on Thursday, 9<sup>th</sup> March at which a Vice Chair will be required to preside for part of the meeting.
