

Questions from the Public under Rule 11

Becca Horn	Thursday 7th September I was at my beach hut by the old	Councillor Roark:
Page	bathing pool when I noticed a suspicious brown cloud in otherwise clear and calm waters emanating from the Combe Haven outfall on Bulverhythe beach (directly in front of the Sea Cadets). Myself and another member of Hastings and St Leonards Clean Water Action Group (CWAG) decided to take a water sample and the results revealed extremely high levels of e.Coli (4400cfu/100ml: the acceptable level for bathing water quality is <500cfu/100ml) and quite high faecal bacteria (280cfu/100ml – the sufficient standard is <185). I have attached a picture and our lab results.	Thank you to the Clean Water Action Group for undertaking this testing and sharing this information. Having discussed this with officers, it seems that similar questions have previously been asked of the Environment Agency, around whether sampling can be conducted away from bathing waters, outside of the bathing season, and/or at a greater frequency. The Environment Agency answer has always been consistent - that they only have the remit (and budget) to conduct routine testing in line with the bathing water directive, i.e., it must be at a designated bathing water and has to be during season. As you say, this location is not a designated bathing water.
	This is not an official Southern Water CSO, although we do not know for sure if outfalls further up the Combe Haven might be having an impact. Nor is this beach a designated bathing water, with free parking, all the beach huts, a playground and toilet facilities close by, many families were in the water through the heatwave and it is a popular area for fishing, water sports and bathing. What can the council do to put pressure on the Environment Agency to test regularly at this spot and investigate the source of this pollution which is a public health hazard?	Having said that, if concerning sampling results have been presented to the Environment Agency they should be responding, even if that response is just to outline their position as has previously been communicated. I can certainly contact the EA and ask them to respond to CWAG on this issue if they have not already. I will also discuss this matter with the rest of Cabinet going forward.

Page 2	major problem that plagues us all. Seagulls are aggressively attacking people on the promenade, as well as creating a major problem by pulling the rubbish from litter bins and wheelie bins alike. They are a growing nuisance in both size and numbers, and although this problem is not unique to Hastings, we aren't implementing enough measures to prevent the mess made by these birds, our wheelie bins need to be emptied more frequently, and the ones with broken lids need to be replaced. The street sweeping team does a good job of cleaning up after the birds, but it would be much better to prevent it in the first place. Recycling in the pink plastic sacks is also contributing to the issue, solid plastic wheelie bins for recycling would be a major improvement. When it's windy at night, there is a lot of loose plastic packaging being blown into the sea and causing plastic pollution. As a town that thrives on tourism, this experience of having to weave through and step over mounds of rubbish on the street is one that is off-putting to both tourists and local residents alike. What plans are in place to improve the on-street litter bins to prevent access to gulls, and also to improve residential waste containers to the same end?	to Hastings and St Leonards but is a frustrating one for residents. Some of the ways to help prevent seagulls getting access to rubbish and recycling are for residents to make sure that recycling has been rinsed and is clean of food debris, and to tie bags up securely (preferably using strong bags or double-bagging, or using seagull-proof sacks if provided – these are not available for residents on the immediate seafront but are available in other areas without a twin bin service). Presenting waste and recycling for collection on the morning of collection day, rather than the night before, also reduces the window of opportunity that seagulls have to attack the waste bags. If residents are aware of any broken communal bins or of ones with missing lids please send me the details and I can pass these onto officers. Alternatively, broken or full bins can be reported on MyHastings, as can dropped litter or litter spilled from bags.

Cllr Collins	For the last two and a half years the Burton family memorial on West Hill Road, which is licenced to the Council by the Diocese of Chichester, has been cordoned off because of the unstable cliff face near the site. Recently the area has suffered from neglect and vandalism, and there have been repeated episodes of fly-tipping.
