The Licence Holder/DPS had been invited to attend the hearing, but was not present. Cllr Roberts Proposed that the Hearing continue, which was seconded by Councillor Charlesworth.

48E APPLICATION FOR THE REVIEW OF A PREMISES LICENCE FOLLOWING CLOSURE ORDER: BEYOND THE SOUND NIGHTCLUB, 20 ROBERTSON STREET, HASTINGS

The Licensing Manager presented the report of the Assistant Director of Environment and Place in respect of an application to review the Premises Licence under section 17 of the Licensing Act 2003 as a result of a Closure Order for Beyond the Sound, 20 Robertson Street, Hastings, TN34 1HL.

Members confirmed they had received the supplementary witness statements.

Mr Scrase, Senior Licensing Officer (Applicant), said he instigated the review of the premises licence following evidence provided by Sussex Police relating to the Closure Order.

Members sought clarification and received answers to their questions.

Mr Savill, Counsel for Sussex Police Authority, made his representation on the grounds of Crime and Disorder and Public Safety. He referred to the witness statements provided by Sussex Police in the supplementary papers and recommended the premises licence be revoked.

RESOLVED (unanimously) to REVOKE the licence as follows:

The reason for this decision was:

The Committee believe that the licensing objectives of Crime and Disorder and Public Safety have been seriously undermined by the Licensee and DPS.

She has not engaged with the Police investigation into the matter failing to report the incident. It is alleged that she tried to cover up the incident by offering bribes.

This conduct falls seriously short of a responsible Licence Holder and DPS. The Licence Holder and DPS failed to attend today's hearing to explain her conduct nor did she send a representative.

The safety of the public is of paramount importance therefore the Committee believe that revocation is the only practical solution to this problem. The Committee have had regard to the Secretary of States guidance.

Purpose of Report

To consider the application for a new premises licence as a result of fourteen representations received.

Responsible Authorities. Two.

Interested Parties. Twelve.

Recommendation(s)

1. Members consider the content of the report, options available and determine the application.

Reasons for Recommendations

The Licensing Act 2003 requires a licensing sub committee to consider such applications when appropriate representations have been made. The decision reached at the sub committee can be subject to appeal by any party to the hearing who is aggrieved by the decision.





Introduction

1.0 Background

- On 7th February 2005 the Licensing Act 2003 came into force for all local authorities, marking the practical commencement of the Government's new liquor licensing regime.
- 2. On the 4th April 2016 Hastings Borough Council received an application for a new premises licence for Yella Shop, 34 Kings Road, St Leonards on Sea from Arka Licensing Consultants Ltd, Unit B003, Tridents Business Centre, 89 Bickertsteth Road, London SW17 9SH on behalf of Mr Anton Thevarasa Johnpillai, 34 Kings Road, St Leonards on Sea, TN37 6DX, made under section 17 the Licensing Act 2003. (Attached at Appendix A).
- 3. This premises is a convenience store that does not hold a licence under the Licensing Act 2003 and is now applying for a new premises licence, a map of the location is attached. (Appendix B.)
- 4. The premise is located within Area 3 (Central St Leonards) of the Council Special Saturation Policy (Cumulative Impact).
- 5. The Special Saturation Policy (Cumulative Impact) is contained within the Council's Licensing Policy, it states "Each application will be considered on its own merit. Where no representations are received any application will be granted in terms consistent with the operating schedule. Where relevant representations are received in relation to applications for the grant of a new premise licence, club premise certificate or provisional statement; there will be a presumption against the grant of such licence or certificate unless the applicant, in the operating schedule, can rebut the presumption that the granting of such a licence or certificate would undermine the licensing objectives." Applicants are advised to seek legal advice if making an application for a licence in a Special Saturation Area.
- 6. In addition, at the latest statutory review of the Licensing Policy carried out at the end of 2015 and published in January 2016 a matrix was added to the policy. This matrix was published to help give clearer guidance to applicants for premises licenses as to how the Council would prefer the area to develop from a licensed premises perspective, and what type of application if applied for, would suit this best.
- 7. This matrix clearly shows that an "off" licence is not the preferred type of premises within a Saturation Area and therefore an applicant will need to clearly demonstrate that the issue of such a licence will not add to the identified problems of the area. This is in accord with the local policy details set out in paragraph 5 above.





2.0 Application

- 8. The application requests the following:
- 9. To have supply of alcohol for "Off" sales on Monday to Saturday from 08.00hrs to 23.00 hrs and Sunday from 10.00hrs to 23.00hrs.
- 10. To have opening hours of the premises, Monday to Sunday from 06.00hrs to 23.00hrs.
- 11. When submitting an application for a licence under the Licensing Act 2003 the applicant is asked to describe what steps they intend to take to promote the four licensing objectives:-
 - the prevention of crime and disorder,
 - public safety,
 - prevention of public nuisance,
 - protection of children from harm.
- 12. In this case, the applicant has made a declaration under part "M" of the application and on a separate document attached to their application.(See appendix A)

3.0 Consultation

- 13. The Licensing Act 2003 requires an applicant to advertise their application once in a local newspaper and on the premises by way of an approved notice for 28 days to allow for representations to be made, this has been done.
- 14. Copies of the application are required to be served on a list of responsible authorities at the same time as placing the application before the local authority, this has been done.
- 15. As a result of this process a representation has been received from Chief Inspector Phelps, Hastings Police Commander, he comments on the application and the proposed activities, he also comments on the applicant's failure to demonstrate that there will be no negative cumulative impact as the premises is within the St Leonards town centre saturation zone. He further comments on the existing problems in the area and as part of his application he includes a statement from a local police sergeant. Sussex police invite the sub-committee to refuse the application. I consider this a valid representation under the licensing objectives (Prevention of Crime and Disorder) (Attached appendix C.)
- 16. A further representation has been received from Mr Trevor Scrase, Senior Licensing Officer, Hastings Borough Council he comments on the application and the police response. He highlights the Council Saturation Policy Area for St Leonards on Sea and comments that the applicant has not in his opinion properly addressed it in their application. For this reason he invites the Council to apply its own policy and refuse the application. (Attached appendix C.)





17. Twelve other representations have been received from local interested parties, including local Councillors. They all comment on the existing problems in the area and how this application will add to those issues. I consider these to be valid representations under the Act. (Attached appendix C).

4.0 Legal Considerations

- 18. The Licensing Act 2003 is now the only legislation that allows premises to be licensed for either the sale of Alcohol or the supply of regulated entertainment.
- 19. If a relevant representation to an application is made by either a responsible authority or an interested party and no compromise can be reached between the parties, a hearing must be held.
- 20. The Department for Culture, Media and Sport has issued guidance under Section 182 of the Licensing Act 2003. This guidance is provided to Licensing Authorities to assist them in carrying out their functions.
- 21. All members of the Licensing Committee have been supplied with copies of the DCMS Government guidance and the Hastings Borough Council Statement of Licensing Policy.
- 22. Human rights considerations must be taken into account fully in balancing licensing issues, in particular, Article 1 of the first protocol and article 8. Article 1 relates to the protection of property and the peaceful enjoyment of possessions and property. Holding a premises licence would be considered a possession. Article 8 relates to the right to respect for private and family life, home and correspondence. These are however qualified rights and can be deprived of "in the public interest". Interference is permissible if what is done:-
- Has its basis in law;
- Is necessary in a democratic society to fulfil a pressing need or pursue a legitimate aim;
- Is proportionate to the aims being pursued; and,
- Is related to the prevention of crime; or, the protection of public order or health.
- 23. If members choose to refuse the application in full or in part, the applicant has a right of appeal to the Magistrates' Court. There is also a right of appeal to conditions imposed as a result of the hearing by any person affected by the decision.

- 27. Refuse the application.

a) General – all four licensing objectives (b, c, d and e) (please read guidance note 9)

This is a new application for an existing premises which is a local store established for a long time. The store would like to have all products available to its customers. The licence holder understand that the premises is situated in the cumulative impact/ Saturation policy area. Thus the licence holder has proposed number of conditions to be added to the licence as part of its operating schedule. In particular the store will not be selling alcohol in single cans or strong beer over 6.5%. The licence holder also a personal licence holder, has worked in the licensing sector for long time, has extensive experience. The store will not add to any extra problems to the already existing one, as it has proposed many conditions to ensure no additional problems are created. The majority of its customers would be the existing customers who has no need to visit other shops to buy an alcohol. The shop alcohol space in the shop and its sales would be less than 20%, represents small percentage of the overall sales. The hours of sale of alcohol starts 8am, and Sundays 10am, late start to address to early morning drinkers.



At least one camera shall cover ingress/egress points and at least one other camera shall cover the alcohol display area.
- 3. Notices shall be displayed advising that CCTV is in operation.
- 4. Staff shall be fully trained in the operation of the CCTV system and there shall be at least one member of staff on duty during trading hours who is able to provide copies of CCTV recordings to the Police and authorised officers of the Local Authority. 

RE: APPLICATION FOR THE GRANT OF A NEW PREMISES LICENCE FOR THE YELLA SHOP 34 KINGS ROAD ST. LEONARDS ON SEA EAST SUSSEX.TN37 6DX.

I write on behalf of the Chief Officer of Police for Sussex to raise a representation against the grant of the above application on the grounds that the grant of a premises licence for these premises will not promote the licensing objectives, and will give rise to potential negative cumulative impact via an increase in public nuisance and crime and disorder. We also make reference to the Hastings Borough Council Statement of Licensing Policy.

The area surrounding the premises is densely populated with licensed premises and suffers from significant crime and disorder and public nuisance. It is situated within the Hastings Borough Council Special Saturation (Cumulative Impact) Policy (HBC SSP), and the Chief Officer of Police contends that any additional licensable activity in the CIA would increase the negative cumulative effect caused by a saturation of licensed premises in the area.

On the 10th March 2016 Sussex Police received from Ms. Adriana Veleva of ARKA Licensing Consultants, representing the applicant Mr. Anton Thevarasa Johnpillai, a draft copy of the application. Accompanying the application was an additional document listing the applicants proposed conditions to promote the four licensing objectives.

Ms. Veleva sought pre-application advice from the Responsible Authorities with regard to the application. Mr Anthony Masters, Sussex Police Licensing Officer, advised Ms. Veleva that the conditions proposed were those expected within any premises licence application in the town, and pointed out that the premises is situated within the HBC SSP. In addition Mr. Masters made reference to the relevant parts of Hastings Borough Council Licensing Policy and the Revised Guidance issued under Section 182 of the Licensing Act 2003.

In summary Mr. Masters advised the Applicant that Sussex Police considered that the Application did not meet the 'exceptional circumstances' criteria, and therefore Sussex Police would be placing a representation against the grant of the licence.

On the 5th April 2016 the formal application was received from Ms. Adriana Veleva on behalf of ARKA Licensing, representing Mr. Anton Thevarasa Johnpillai of 11 Hornfield Terrace Hastings East Sussex. TN37 6JD.

The formal application almost mirrored the draft copy other than slightly amended times for the supply of alcohol (from 6am to 8am start time) and an amendment of the percentage floor space and business to be devoted to the supply of alcohol.

The proposed hours the premises will be open to the public are:

Monday to Sunday.

06:00hrs - 23:00hrs.

The application is for the grant of a premises licence, made under Section 17 of the Licensing Act 2003, for the licensable activity, supply of alcohol. Times proposed for the licensable activity are:

Monday to Saturday.

08:00hrs - 23:00hrs.

Sunday.

10.00hrs - 23.00hrs

The licensed area will be restricted to the ground floor only as detailed within the accompanying plan.

The concentration of licensed premises within a small area of the town causes problems of crime and disorder and public nuisance. In consequence of this, the Licensing Authority in January 2008 believed it was both appropriate and necessary to introduce a Special Saturation (Cumulative Impact) Policy. The policy was reviewed in 2009 when small amendments were made. Further reviews took place in January 2011, February 2013 and again in September 2015 and after this review the policy was readopted in January 2016, resulting in three areas within the town being retained. The policy covers both 'on and 'off' licences.

Paragraph 13.30 of the Secretary of State's Revised Guidance issued under Section 182 of the Licensing Act 2003, amended in March 2015 provides, "The effect of adopting a special policy of this kind is to create a rebuttable presumption that applications for the grant or variation of premises licenses or club premises certificates which are likely to add to the existing cumulative impact will normally be refused or subject to certain limitations, following relevant representations, unless the applicant can demonstrate in the operating schedule that there will be no negative cumulative impact on one or more of the licensing objectives. Applicants should give consideration to potential cumulative impact issues when setting out the steps they will take to promote the licensing objectives in their application".

This principle is reflected in the Hastings Borough Council Special Saturation (Cumulative Impact) Policy contained within the Hastings Borough Council Licensing Policy.

These premises are situated within Area 3 of the Special Saturation (Cumulative Impact) Policy in which there is a presumption that any new premises licence or variation will be refused. The policy states within Section 1.11

"This policy relates to applications for the grant and/or variation of premise licences, club premises certificates or the issue of provisional statements. Each application will be considered on its own merit. Where no representations are received any application will be granted in terms consistent with the operating schedule.

Where relevant representations are received in relation to applications for the grant of a new premises licence, club premises certificate or provisional statement; there will be a presumption against the grant of such licence or certificate unless the applicant can rebut the presumption that the granting of such a licence or certificate would undermine the licensing objectives."

The most recent Hastings Borough Council Licensing Policy now includes the 'matrix approach' to applications and variations. The matrix indicates that an application for a convenience store / off licence situated within an area covered by a Special Saturation (Cumulative Impact) Policy should be refused, unless the Applicant can prove exceptional circumstances.

Paragraph 8.33 of the Secretary of State's Guidance to the Licensing Act 2003, amended in March 2015 provides, 'In completing an operating schedule, applicants are expected to have had regard to the statement of licensing policy for their area. They must also be aware of the expectations of the licensing authority and responsible authorities as to the steps that are appropriate for the promotion of the licensing objectives, and to demonstrate knowledge of their local area when describing the steps they propose to take to promote the

Paragraph 8.35 of the guidance states 'Applicants are expected to include positive proposals in their application on how they will manage any potential risks. Where specific policies apply in the area (for example, a cumulative impact policy), applicants are also expected to demonstrate an understanding of how the policy impacts on their application; any measures they will take to mitigate the impact; and why they consider the application should be an exception to the policy'.

Contrary to the Secretary of State's Guidance, the applicant has failed to demonstrate in the operating schedule that there will be no negative cumulative impact on one or more of the licensing objectives. The application is accompanied by an attachment of conditions. The proposed conditions are those Sussex Police would expect to be contained within an application for this type of business which sits outside the area covered by the Cumulative Impact Policy. The application makes brief reference to Special Saturation (Cumulative Impact) Policy but nothing in the application or the operating schedule either rebuts the presumption of refusal contained within Sect 1.11 of the Hastings Borough Council's Licensing Policy, or provides any reason for the Licensing Authority to depart from its special policy.

The area of central St. Leonards on Sea, in which this premises is located, has a significant problem with members of the street community. The anti-social behaviour of some of these persons have a negative effect not only on the local residents but also on visitors to the town. In order to support the HBC SS, other legislation and initiatives have been introduced in an attempt to combat the alcohol fuelled anti-social behaviour in this area.

These being:-

- Reduce the Strength Campaign. Encouraging licensees not to sell single cans or strong cheap lager.
- A Designated Public Place Order, to enable alcohol to be removed from alcohol upon request.
- Operation Confront, which involves deploying officers to disperse street drinkers and others involved in alcohol related anti-social behaviour.

In addition recognising the problems associated with street drinking the following actions have been taken:-

- A multi-agency forum has been set up, chaired by Amber Rudd MP. The forum meets on a quarterly basis, and is attended by Chief Inspector Phelps, representatives of Hastings Borough Council, and local Councillors.
- A police community office opened in Silchester Road on the 7th August 2015, providing a greater police presence in an area of high anti-social behavior and to combat street drinking.
- In July 2014 Sussex Police held a three day 'Street Community Pop Up Hub'
- The appointment of a Project Outreach Worker.
- Sussex Police have a designated Street Community Officer (PC Freeman) working in Central St Leonards.
- The Hastings Community Alcohol Partnership (CAP) is now back in place following the conclusion of the Hastings Local Alcohol Action Area (LAAA) in April 2015.

Sgt Varrall is the Neighbourhood Police Sergeant for Hastings South which includes the ward of Central St. Leonards and he has submitted a statement which details some of the issues experienced in the area. This statement is attached.

Sussex Police contend that the applicant has failed to demonstrate any exceptional circumstances to justify departure from the HBC SSP policy. We further contend that the steps proposed within the operating schedule fail address the issue of cumulative impact. Sussex Police contend that the carrying on of licensable activity at

these premises will add to the existing negative cumulative effect in an area already saturated with licensed premises.

Therefore, Sussex Police invite the Licensing Authority to refuse this application.

Road, St Leonards On-Sea, East Sussex. We work from a local office in Silchester Road, which has only London Road between them.

The reason for Hastings and St Leonards having to put a team into Silchester Road, is due to the tensions in the local area. These tensions relate to a variety of issues locally around drug supply, members of the street community/rough sleepers and a problem youth group.

The current top priority locally is around a group of youths who are being managed under operation Unit. The group of youths base themselves outside the King Road fish and chip shop, Kings Road, St Leonards On-Sea, East Sussex. They range from approximately 5-6 youths in a group and up to around 20 youths when they are at their strongest. The youths are known to take drugs, drink alcohol and cause a general nuisance to the local community. The problem is so prolific that for the past three weeks we have had to resource two pairs of officers in Kings Road every evenings and during the weekend days and evening, to manage the youths and disperse them from the area. This has resulted in stop checks, stop searches, dispersals and also multiple arrests when the group decided to cause mass disorder. This is a prolific problem which would be made worse with the inclusion of yet another licenced premises in the area. The licence premises would be directly opposite the problem youths on the other side of the road, within 40-50 metres. At this time the shop does not open in the evenings and therefore does not draw any attention from the youths. If this was to open late or offer alcohol on the weekends during this would cause the youths to congregate around the premises.

Another large issue in the local area is that of members of the street community. There are currently 110 members of the street community. The majority have duel diagnosis mental health issues, drugs and alcohol abuse issues. The members of this community will notoriously congregate around licenced premises, Page 33

whether the alcohol is purchased by them or for them by other members of the public. We face a constant daily battle from all angles in controlling these individuals. This is through enforcement, licencing, mental health work and over 20 agencies gather monthly to assist with this. There are a large number of licenced premises in the area and this is already difficult to manage. Kings Road is the main business street in the area and is very much up and coming. The shift in the area over the past few years is that of improvement with tourism thriving. Adding a licenced premises to the middle of the street would increase crime and disorder from the street community in the heart of the central St Leonards. This would be the case if open morning, day or night. The street community have been seen to congregate from 0600 hours onwards. It is of my professional opinion that I would be against any alcohol licence being agreed at 'The yella shop' in Kings Road. I do not feel that any conditions imposed would be proportionate for the area in which the premises is situated. Simply hiding the alcohol and not allowing this to be on show, does not have any effect on the sale of alcohol. The licence in my opinion would only have a detrimental effect on the local community and crime and disorder as explained above. Sussex police have adopted two directed patrol activities in this

street and have also had to install an anti-social behaviour camera on a lamppost, which monitors the middle

of Kings Road. This provides us real time footage of the anti-social behaviour in this area.

Licensing representation against the new premises licence application for the Yella Shop, 34 Kings Road, St. Leonards on Sea.

A new premises licence application was received by this licensing authority on the 4th April 2016. The consultation period ends at midnight on the 2nd May 2016.

The application has been submitted by Arka Licensing Consultants Ltd, Tooting, London, on behalf of Mr Anton Thevarasa JOHNPILLAI, of an address given as 11 Hornfield Terrace, Hastings, TN37 6JD. He is applying for a premises licence for an existing retail shop at 34 Kings Road, St Leonards on Sea, requesting authorisation for the sale by retail of alcohol for consumption off the premises, Monday to Saturday 06.00 hours to 23.00 hours, Sunday 10.00 to 23.00 hours. .

Although the application is lawful under the requirements of Licensing Act 2003, the premises is located within the Central St Leonards cumulative impact / saturation policy area 3. (First implemented in January 2008 and reviewed several times since).

The licensing policy, amended in January 2016, in line with Home Office requirements has been reviewed. The saturation policy for the Central St Leonards area remains the same involving the roads of:-

3: Central St Leonards

London Road (A2102) from its junction with Grand Parade (A259) to its junction with Silchester Road (UC 3140F)

Kings Road (UC 3145A) from its junction with London Rd (A2102) to its junction with Western Road (UC 3144C)

Western Road (UC 3144C) for its entire length

Norman Road (UC 3141A) from its junction with Gensing Road (UC 3141A) to its junction with London

Norman Road (A2102) from its junction with London Road (A2102) to its junction with Warrior Square (A2102).

A matrix has been included in this review, which outlines the various types of application and the advice included as to the probability of the grant of a new premises licence under these

circumstances. On page 15, the matrix advises that an off licence in a cumulative impact area is unlikely to be granted.

Central St Leonards has a well documented history of anti social behaviour caused by street drinkers. I have received a representation from Mr Anthony Masters, Police Licensing in respect of this application. This is supported by a statement from Police Sergeant Christopher VARRALL, the officer in charge of the neighbourhood policing team covering this area of Central St Leonards on Sea. Police comment on these issues and the measures that have been adopted by multi agencies to deal with the effects on the local community. This process is ongoing.

Since the implementation of the Licensing Act 2003, on the 24th November 2005, the off sales retail premises in this area is as follows:-

Before saturation policy implemented in 2008:-

- Londis, 21 23 Norman Road granted on transition. Transferred in April 2006 to current licence holder.
- Mary's Premier Food Market, 20 Norman Road granted on transition.
- Co-Operative, 30 32 London Road granted on transition.
- Costcutter Newsmart, 48 London Road granted on transition to existing licence holder.
- Spar, 29 30 Kings Road granted on transition.
- Western Road Stores, 30 Western Road granted on transition to existing licence holder.

Since implementation of the saturation policy, the following have been granted:-

- Phoenix & Plum Wines, Kings Road a specialist vintners granted in October 2013;
- London Convenience Store, 13 London Road granted at licensing sub committee hearing on the 30th November 2015. The grant of this premises licence is an ongoing basis of complaint involving further action by police and licensing, resulting a a minor variation in respect of the shop plan granted in January 2016. The premises licence holder is the wife of the holder of Londis, Norman Road, which is actually located next door.

A previous applicant for the Yella Shop had their application refused at licensing sub committee on the 8th September 2014.

Comments on the application.

On examining the application for the Yella Shop, which was received and registered in my absence, I make the following comments:-

- 1. No pre application advice was sought by the applicant or their licensing agent, with us as the licensing authority, before the application was submitted to the best of my knowledge and belief. As the licensing officer primarily dealing with such applications, I would have been asked or appraised if such advice had been requested.
- 2. The application form has been typed up, probably by an employee of Arka Licensing Consultants Ltd. The address given for the applicant is 11 Hornfield Terrace, Hastings,

TN37 6JD. On checking there is no such road as Hornfield Terrace but there is a Cornfield Terrace, St. Leonards on Sea, TN37 6JD.

- 3. The Consent of individual being specified as premises supervisor form, also has the 11 Hornfield Terrace, Hastings, TN37 6JD address. Although this has been handwritten the applicant has signed the form on page 2 and no correction has been made to the incorrect address. This may be a genuine clerical error but it is repeated twice in the application.
 - 4. Enquiries have been made with Wakefield Council, the issuing authority of the personal licence Number PA2805 issued to the applicant Anton Thevarasa JOHNPILLAI. The purpose of this enquiry is to establish the experience and validity of the applicants personal licence, issued on 3rd January 2013. (Comment on Page M of the application, it states that, 'the licence holder, has worked in the licensing sector for long time, has extensive experience.' It is my submission that three years as a personal licence holder is hardly a long time, neither would it be sufficient to gain extensive experience. No further information is given to support this statement). The response from Wakefield Council is that the details provided of the personal licence are correct with the exception of the address, which has yet to be notified to Wakefield Council in accordance with the requirements of Section 127 of the Licensing Act 2003.
 - 5. There is no indication in the application if the applicant owns the Yella Shop, or indeed who owns the shop. Therefore how can any relevance be given to the statement of 'it being a local store established for a long time?' That is a fact but if the applicant has only just taken over the business, the how long has the applicant owned it? This will have a lot of relevance to a full understanding of the local problems and issues. If he is a new trader, it is unlikely that he is fully aware.
 - 6. In the operating schedule, Page M refers, in a) General, it states that the applicant is aware of this being in the saturation policy area and offers additional measures to promote the licensing objectives, in particular the prevention of crime and disorder. One of these is that single cans of strong beer over 6.5% abv will not be sold.
 - 7. Additionally the alcohol sales area will be less than 20% of the space in the shop.
 - 8. Reference is made to, 'the store will not add to any extra problems to the already existing one, as it has proposed many conditions to ensure no additional problems are created.' (Comment see below).
 - 9. The additional measures (conditions) offered and referred to as 6, 7, 8 above were included on separate pages submitted with the application. These outline what would be expected of any retail shop selling alcohol for off sales consumption, due to the additional responsibilities involved. There is nothing offered over and above the standard conditions to reflect the saturation policy. How the issue of a further premises licence for the sale of off sales alcohol in an existing problem area of the borough will not add to the existing problems, will not be apparent until after it has been granted, which will be too late, in my opinion.









10.1 see nothing within the application to indicate any exceptional circumstances why this application should be granted.

It is for these reasons that I submit this representation, on behalf of Hastings Borough Council Licensing, as a responsible authority under the Licensing Act 2003 (as amended), and that this application should be brought before the licensing committee for decision, with a view to their consideration for its refusal in line with the police representation, representations from other persons and the areas outlined in my report.

Bob Brown and the Licensing Department

We are writing to register our objection to the application for a premises licence by The Yella Shop. 34 Kings Road. The basis for which is that granting a licence for these premises will not promote the licensing objectives, particularly the prevention of crime and disorder and public nuisance.

The Yella Shop at 34 Kings Road sits within one of the Council's Cumulative Impact Areas (or Saturation Zones). As our own policy states, "These areas have been specified because the licensing authority believes that the cumulative impact of the number and concentration of licensed premises in these areas is adversely affecting the promotion of the following licensing objectives: Prevention of Crime and Disorder and Prevention of Public Nuisance."

Crime, disorder and public nuisance are already at problem levels for the police. Last year the force moved a community hub to be based within our ward so that they could have a more active and closer response to these issues. Indeed from March 2015 to February of this year there were 562 recorded cases of anti-social behaviour and 283 recorded instances of violent crime within Central St Leonards (http://www.ukcrimestats.com/Neighbourhood/Sussex_Police/Central_St_Leonards). It is important to note that those of course are only the 'recorded' cases and do not account for the more minor day-to-day instances of public nuisance which can equate to much more than those evidenced.

We feel that enabling this premise to sell alcohol would be detrimental to the aims and objectives of the saturation zone and overall licensing policy. One of the main principles of the policy is to reduce alcohol misuse. We would ask the question of how this can be done by adding to the proliferation of off-licenses in the area. As part of the council's new matrix approach to licensing, off-license premises when in a cumulative impact area are listed as No's in terms of granting policy. Furthermore, even when not in a Saturation Zone, for any off-license in an area of mixed commercial and residential use, a description which could be used for Kings Road, a licence should be restricted to 10pm yet the applicant is requesting licensed hours to 11pm every day of the week. This to us already shows the applicants unwillingness to abide by our licensing policy despite any measures which they may put in place to counter balance any negativity.

It is a known fact that the street drinking community cause disproportionate problems in parts of the borough. This can be in terms of public nuisance due to their increased levels of anti social behaviour in relation to their alcohol misuse or indeed in terms of public safety. Adding another off-license outlet would only add to this issue. Many individuals from the street community have been dangerously close to being involved in an accident with a moving vehicle. Some of these instances we have witnessed ourselves in person. Adding to the ready supply of alcohol will only add to this problem and will extend it fully from London Road and Norman Road through to Kings Road where it is already an issue. Certainly we feel that by adding another off-licensed premise to the Saturation Zone will not allow for the licensing objective of public safety to be promoted.

Kings Road is the main link from the station to the seafront and the centre of St Leonards. The negative affect of another off-license will not only impact the residents of the local area but also tourists and visitors to our town. The further proliferation of alcohol sales is not only unnecessary but we feel would be in direct contrast to the licensing objectives.

In view of all that is mentioned above, we would urge the committee to refuse the application Yours faithfully.

Objection to license application for - The Yella Shop 34 Kings Road, St Leonards- on-Sea, N38T I am writing to formally lodge an objection to the application for a new convenience store and in particular to the application to sell alcohol for consumption off the premises at the above address on the following grounds as outlined in the licensing objectives of The Licensing Act 2003:

PREVENTION OF CRIME AND DISORDER

Current high levels of anti-social behavior in this location caused by people with alcohol and drug misuse issues already demand heavily on police resources. The huge demands on their time & resources are only likely to increase if new or expanded licensed premises are allowed. Increasing the availability of alcohol in this location is highly likely to add to the already levels of crime and disorder. It also makes it hard for the licensed shops to ban problem customers away from the area as there are so many to visit along one strip.

PUBLIC SAFETY

The application should be declined on the grounds of public safety concerning the location of the premises in an area already swamped by a monopoly of shops selling bargain alcohol. This is on top of numerous pubs. How much alcohol can one small community area need or take? This area of Central St Leonards is already a favoured meeting spot for local street drinkers and there have already been numerous near misses with drunk individuals staggering across roads into traffic. The train station is located at the top of the road & it can be very intimidating walking home (or zigzagging your way) from the station at night dodging groups of junkies & drunks scattered along the pavements of Kings Road & London Road. It also puts you off entering the shops when you have groups gathering around their doorways it can be extremely intimidating. The elderly are dependent on their local shops & sometimes a trip out to the shops provides the with their only social interaction in the day. These groups often hog the path & force you off the pavement to avoid them. That presents physical obstacles for the frail. They should not have to worry about public nuisance preventing their daily right of the simple pleasure of a walk to their local shops. It also produces hurdles for parents trying to weave down these street with push chairs.

PREVENTION OF PUBLIC NUISANCE

The public nuisance caused by the activities of street drinkers and those with alcohol addiction issues is already out of hand & straining local authority resources. This creates a tense atmosphere as there can be loud disputes within these groups sometimes leading into violence. The train station is located at the top of this road & it can be very intimidating walking home from the station at night dodging groups of junkies & drunks scattered along the pavements of Kings Road & London Road, standing in groups hogging the pavements or lying slumped across them. It is also makes a depressing & stressful introduction to St Leonards for any newcomer stepping off the train & making their way down Kings Road to the seafront. There is also regular vandalism at what is a really attractive old station building. HBC have invested a huge amount of effort into reopening the pier & this will hopefully see more people arriving at St Leonards Warrior Square Station. HBC have a responsibility to ensure visitors have a great experience not just on the pier but en route to it. The infamous Central St Leonards Obstacle Course does not make a great entree - dodging the drunks, junkies, hurdling litter, leap frogging broken glass and dog shit is not an arcade of amusement reaping reward for the local community & prospects for business enterprise.

PROTECTION OF CHILDREN FROM HARM

Wherever possible, children should be shielded from exposure to drug and alcohol misuse and related crimes. Yet more premises selling alcohol and cigarettes will increase the likelihood of children being exposed to harm and opportunity of under-age young adults obtaining alcohol. There is a really good art & crafts shop a few doors up from this premises, this should be an inspirational place for youngsters to spend pocket money at weekends. Children use the railway, walking to & from it past this premises with their families & also on their own for school journeys. As a non driver I am dependent on the train & I walk to the station, I frequently hear people around the station premises loudly discussing drug deals. In the past couple of weeks I have twice seen police at the station having to deal with unsocial behaviour. As this specific area is a social gathering place for addicts the station becomes an obvious meeting place. I have also been approached by addicts begging for money, there is regular vandalism at what is a really attractive old station building. I have friends who did not wish to start a family in this area and despite living here for many years moved away when they had children to nearby towns to ensure their children a safer upbringing. We must ensure residents stay in this area when they have families, not be driven away from it. This in turn will encourage a healthy flow of new families moving here.

Many adults spend a huge amount of time cocooned in the safety of their cars able to park up outside wherever they visit, even for the shortest journeys. It would be enlightening for more to cycle & walk around their neighbourhood as it would enlighten them first hand as to what the young & elderly experience on their streets. It is the most basic right from young to old to be able to walk or cycle around your neighbourhood safely & experience a pleasant peaceful time doing so.

Objection to Licence Application for 34 Kings Road, St Leonards on Sea.

I wish to object in the strongest possible terms to the above application, for the following reasons:

1. I notice that a similar application has already been rejected at this address as recently in 2014.

2. Granting such an application would be **entirely inconsistent** with the aims for the protection of St Leonards Town Centre, again stated recently in no less than the Labour Manifesto for our local elections. I am sure these stated intentions would also engage cross party support. They seek to, I quote:

"use (their) new licensing policy to **RESTRICT** (my capitals) the proliferation of off-licences in our town centres" and to "work with the police to develop tailored Public Space Protection Orders coupled with Community Protection Orders to address problems associated with street drinking". I am also sure that, as in a recent St Leonards licence application hearing, the police will not be enthusiastic about supporting this one in Kings Road.

3. Protection of Crime and Disorder

Granting this application would be entirely inconsistent with limiting and policing current high levels of anti-social behaviour in this area due to alcohol and drug abuse. As a single female resident of St Leonards, I find such existing behaviour curtails my enjoyment of the town during the daylight hours now as well as in the evening. Many of my friends in a similar position are also intimidated and frightened by the increasing appearance of alcohol-fuelled aggression and crime.

4. Public Safety

This would certainly, as I have already suggested in point 3, be threatened further were such an application to be granted. The premises in question are situated in Kings Road. I regularly drive down this street to the station and beyond and frequently, almost daily, have pedestrians stepping in front of my car because of their degree of intoxication. I certainly am already becoming wary of walking down this street, even in daylight, which is especially worrying and annoying

given that it leads to our local railway station.

5. Prevention of Public Nuisance

The level of public nuisance caused by street drinkers and their alcohol addiction is already unacceptable. It does little for the town that they lie in the road, swearing and menacing other pedestrians, often seeking funds to purchase more alcohol. This is particularly inappropriate and offensive next to Warrior Square Station. Kings Road should be an attractive and peaceful avenue to St Leonards Centre for its residents, visitors and tourists.

6. Protection of Children from Harm

As a retired secondary Deputy Headteacher I am appalled that such an application should even be presented and considered when children in our town centre are already at such a high degree of risk from over-exposure to alcohol and drug abuse. Such examples of unacceptable behaviour can only damage them in every possible way. Granting this application will encourage this and the availability of alcohol to be purchased and abused by our young people.

I ask you, please, to reject this application. It is entirely inappropriate that the community of St Leonards is asked to accept yet another establishment selling alcohol.

The shop is in a Saturation Zone, and the Negative Cumulative Impact issues are important, including the many forms of antisocial behaviour. But antisocial behaviour can extend to expensive barristers, as in last year's Barraclough & Stiles case. Applicants for that London Road off-licence lied multiply about the application:

- that local street-drinkers had somehow relocated to Hastings. (They hadn't.)
- that the applicants observed the Reduce-the-Strength campaign in their old shop. (They didn't.)
- that applicants would observe the Reduce-the-Strength campaign in their new shop. (They didn't.)
- that the new shop would have a minor display of alcohol. (It didn't.)

Despite detailed opposition by the Sussex Police and HBC licensing officers, the application was approved by HBC with the nonsensical statement that

No factual evidence was provided by the police.

Despite multiple breaches of its conditions, the licence was not revoked.

The unsatisfactoriness and dubiety of this system of regulation is increasingly clear — even before matters such as the right to appeal (for more than £410) are considered.

Reject this application.
