Action: ALL • Community impact of COVID-19 – links to Hastings specific research will be circulated. Action: Steve

<p>3</p>	<p><u>COVID-19 UPDATES</u></p> <p>Public Health update Darrell Gale, Director of Public Health gave a presentation where he explained the patterns and trends in cases from January to February, testing and positivity rates across East Sussex and the impacts on the area and the health care trust. A copy of his presentation will be circulated with the minutes of the meeting.</p> <p>Concerns were raised as Special Education Needs and Disabilities (SEND) school staff have already received letters from the NHS offering vaccinations. There needs to be consistency and the same support needs to be offered to mainstream schools and colleges. Darrell agreed to take this up with colleagues.</p> <p>Vaccination programme update Candice Miller, Assistant Head of Health, Wellbeing and Partnerships at NHS East Sussex CCG gave an update:</p> <ul style="list-style-type: none"> • To date, 550,000 vaccinations have been delivered across Sussex, including 535,000 first doses • Majority of those in the first four priority groups have either been fully vaccinated or received the first dose vaccination • 72.3% of those in priority group 5 (All those 65-69 years of age) have received the first dose vaccination • There is one primary care network serving Hastings and St. Leonards, operating from Kings Church Centre and over 17,000 vaccinations have been given since the programme began • There are seven hospital hub vaccination centres across Sussex including the Conquest Hospital • Three pharmacy-led services are running in East Sussex, including Laycocks Pharmacy in Ore. Each county has a large vaccination centre, which is the Welcome Building in Eastbourne. <p>5</p>	<p><u>HASTINGS TOWN DEAL - TOWN INVESTMENT PLAN AND NEXT STEPS</u></p> <p>Carole Dixon, Co-chair of the Hastings Town Deal Board gave an update:</p> <ul style="list-style-type: none"> • The Town Investment Plan has been submitted. It is hoped the outcome of the submission will be known on 31st March • The formation of the Town Deal Board will be considered in the near future following the outcome of the submission • The vision, 12 challenges for the town, the 4 challenges that the Town Investment Plan is focused on, and the project prioritisation and engagement processes were explained • The projects within the Town Investment Plan were summarised • More detail can be found on the Hastings Town Deal blog 	
<p>6</p>	<p><u>POST EU ARRANGEMENTS - IMPACT AND LOCAL UPDATE</u></p> <p>Sean Dennis, Director, Hastings Area Chamber of Commerce reported that:</p> <ul style="list-style-type: none"> • The movement into Brexit has not been as problematic as predicted, although there have been a few isolated cases with specific concerns, including a wholesaler/importer which is possibly looking at ceasing trading • The other key issue that is known is around freight, which there are two aspects to: 1) the increasing cost of containers and physically importing product into the country, and 2) the time taking for product to come into the country, which does not seem to be restricted solely to the EU • Reports are being received that the new paperwork processes and procedures are causing difficulties and delays in transporting products to and from the EU, although this also seems to be happening globally. Often there are 2-3 week delays in products arriving in the country. It is hoped these constraints will improve over time • Feedback received from local businesses is still mainly around the impacts of COVID-19 lockdown and it is hoped that there will be more announcements regarding support to businesses in the Chancellor's budget statement on Wednesday <p>Kevin Boorman, Marketing and Major Projects Manager at HBC added that:</p> <ul style="list-style-type: none"> • There were concerns at one point that the Kent permit was going to be a major issue, particular with vehicles coming along the south 	

	<p>coast, but these did not materialise</p> <ul style="list-style-type: none"> • The export of seafood has been a problem in other parts of the country, but not in Hastings. The product is exported from Hastings Fishmarket, via Chapman's in Rye. Not a single consignment has failed to get through to Europe, thanks to very close working between the fishing fleet, Chapman's, the council and Rother District Council and which is a really positive story • Even without COVID-19, there had been concerns about the impact of the exit from the EU. COVID-19 has affected the international tourism market and if the UK is seen to be a COVID-19 hotspot, there will be long term impacts on tourism and its recovery. Around 20% of annual tourism spend comes from overseas and this has been lost this year • It is hoped events may be able to take place late in the Summer, which is a positive as it was expected that events would not be allowed • There is still some confusion around accommodation and what can and cannot be done. Most hotels, guesthouses and camping and caravan sites were hoping to be open by Easter, but it now looks like they will not be able to open until May <p>Marc Turczanski updated that from a client facing perspective, COVID-19 has delayed the impact on the workforce. The points-based system has now come in and anyone arriving in the UK from the EU for work purposes has lost the freedom of movement rights that they had prior to this. The next deadline is the end of June, where the interim arrangements for anybody from the EU who is in the UK will be required to apply to the EU Settlement Scheme. Clients are being supported as much as possible, although COVID-19 seems to have delayed the impact.</p>

Motion to Council regarding health inequalities in Hastings

This Council continues to express its gratitude for the extraordinary effort undertaken by many in our Borough during the pandemic crisis that in turn has created a force for good. We are all proud of the response of our Council, our medical professionals, key workers, our partners and the wider community effort across the Borough of Hastings and St. Leonards.

This Council believes that while the overwhelming majority of residents are playing their part in observing COVID regulations and a large number have taken on community volunteering roles, we are not 'all in this together'. When the pandemic is over the most vulnerable groups will still be vulnerable - economically, socially, academically and in their health and wellbeing outcomes. A resident living in one street will still be more likely to die 14 years earlier than a resident in the adjoining neighbourhood. We cannot accept this.

We are a council committed to narrowing the health gap. We are also a Council aware of the limits placed upon us. Therefore, whilst this Council welcomes the work already undertaken by ESCC Director of Public Health, before and during the pandemic, we remain acutely aware of the responsibility a phalanx of public bodies has for improving the health outcomes for our residents over the next decade. We trust the result of this Motion will be to shine a spotlight beyond the well-rehearsed statistical recognition of health-inequality and onto the process by which these public bodies are forming and then acting upon a strategy to eradicate health-inequality from our Borough.

This motion is a challenge for all of us and especially those organisations whose very existence is predicated on improving the health and life-chances of our residents to act particular where there has been longstanding identified need.

The story of the primary care centre in the Ore Valley is a clear example of how desperate need does not lead to the prompt delivery of the required services, on time, to transform the health of our residents in Baird ward.

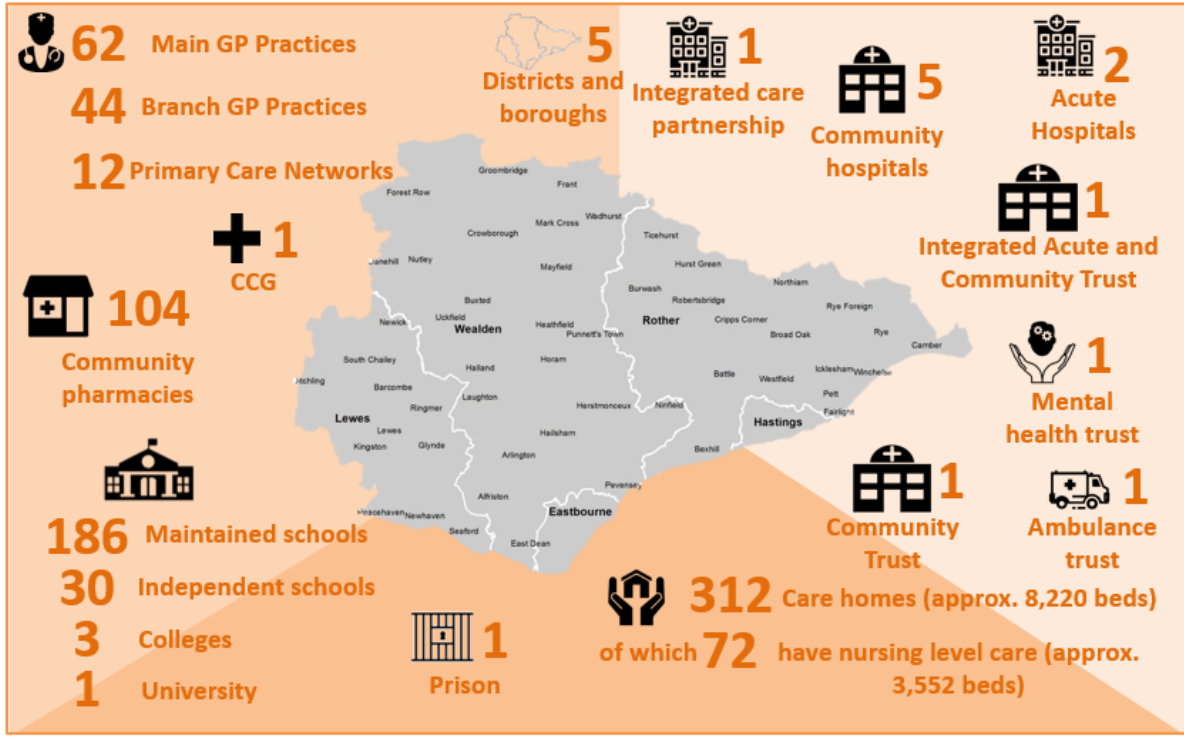
This motion calls on NHS England to deliver this primary care centre as a matter of necessity and as a clear signal of a new desire, the force for good extracted from the trauma of pandemic, to eradicate health inequality in our Borough by 2029.

This Council resolves to:

1. Lobby NHS England and the Secretary of State for Health to deliver on the primary health care centre for the Ore Valley;
2. Encourage formal and informal partnerships to contribute positively to reducing health inequality across the borough;
3. Promote the need for a unifying strategic plan to eradicate severe health inequality from our Borough by 2029;
4. Promote our Corporate Plan, our post-Covid recovery work and all other opportunities and agency as they become available to us as a means to this end;

5. Request a twice-yearly report on the progress of measures, taken by organisations operating within the Borough, to reduce health-inequality using national, county and local profiles from the Director of Public Health
6. Instigate with partners specific locality measures with outcomes that raise the life chances of particular vulnerable groups or neighbourhoods;
7. Consider the impact on public health and inequality of our own decision-making, for example within the draft local plan;
8. Invite our MP to take up the mantle of reducing health inequality in the most deprived wards she represents.
