The Sub-Committee is mindful of the shocking crime statistics presented by the police in relation

		to Robertson Street and Castle Ward. The Sub-Committee believe that allowing this Temporary Event Notice to take place, which would allow longer opening times, would exacerbate alcohol-related crime in the area.
