### 5. <u>APPLICATION FOR A TEMPORARY EVENTS NOTICE, WITH AN</u> <u>OBJECTION. FRENCH'S, ROBERTSON STREET, HASTINGS.</u>

Mr Bryant, the Licensing Lead Officer gave a precis of his report to the Sub-Committee.

On 29<sup>th</sup> November 2021 Hastings Borough Council was served two separate Temporary Events Notice (TEN) in respect of French's, 24 Robertson Street, Hastings. French's already holds a licence to operate until 3am under the Licensing Act 2003 and is located in Area 2a of the Council Special Saturation Policy.

The first TEN provided for an extension of hours from 3am to 5am on 18<sup>th</sup> and 19<sup>th</sup> December 2021. The second TEN provided for an extension of hours on the 25<sup>th</sup> December 2021 from 3am to 5am.

Copies of the TEN were served on responsible authorities at the same time as being placed before the licensing authority. Subsequently an Objection Notice was received from Sussex Police on 29<sup>th</sup> November 2021 and updated 1<sup>st</sup> December 2021 in respect of both TENs. Environmental protection did not make any representations on this occasion.

### 10 DECEMBER 2021

Sussex Police had made attempts to contact the DPS and premises licence holder Mr Foot regarding the Notices by various means, The Licensing Lead officer had also emailed Mr Foot with no reply.

PC Daren Spalding, Sussex Police Licensing Officer, explained that the objection to the TEN was raised under the Licensing Objectives prevention of crime and disorder; public nuisance; and public safety not being promoted. The main reason for the objection was due to recently updated statistics around public place violent crime during the night-time economy.

A previous TEN had recently been agreed for French's in October 2021. However, an objection had been raised on this occasion as the crime statistics, which weren't available in October, show a sharp increase in violent crime in the area.

PC Spalding stated Mr Foot who is the premises licence holder and designated premises supervisor had not added his usual signature to the first TEN, but instead digitally signed it. The first TEN was emailed to the relevant authorities by the manager, Mr Rick Cowlard. It was not received from Mr. Foot's email address. Sussex Police tried to ring Mr Foot on both telephone numbers obtained from the TEN application but received no answer. An email had been sent to Mr Foot to check he is aware of this first TEN.

The second TEN for the 25th of December 2021 stated no entry or re-entry after 3:30 AM. There was no mention of the premises licence conditions being extended for the duration of the second TEN. This second TEN has been physically signed by Mr Foot.

PC Spalding confirmed Sussex Police had seen an increase in the night-time economy since lockdown was lifted earlier this year. There was also the added concerns of violence against women and girls with an increase in suspected spiking incidents.

Recently, Sussex Police obtained up-to-date crime statistics in support of the continuation of the Cumulative impact policy. Police records show that Robertson Street had the highest crime rate compared to any other location within this part of Castle Ward which has the highest public place violence rate in Sussex. Crime was at its highest during the night-time economy. Castle Ward was now ranked 4<sup>th</sup> highest for serious violence in Sussex. Overall, there had been an increase of approximately 49% of public place violent crimes in the Castle ward.

PC Spalding read a letter on behalf of Inspector Aidan Cornwall, District Inspector for Hastings, who was unable to attend the hearing. The letter reiterated that serious violence in Castle Ward continues to be a real concern for Sussex Police and that although additional patrols were being deployed in the town, Sussex Police cannot solve this alone. The letter detailed some of the violent crimes which have taken place in the area over the past month, include a stabbing; rape; knife attack; and violent assault. Each incident has left victims with life changing injuries and all are linked to

the night-time economy and intoxication. The level of intoxication harm being caused within the ward is unacceptable and amongst the highest in Sussex. Any new licence or TEN should not be issued if they are likely to make the issue worse. Sussex Police will therefore continue to object to any new application or TEN within the area until the level of violence reduces.

Mr Cowlard asked Sussex police if they will object to any TEN within the Castle Ward. PC Daren Spalding reiterated Inspector Cornwallis's letter which states the police will object with the crime figures in Castle Ward as high as they are now. Mr Cowlard questioned the police as he has been informed Wetherspoons has been granted two TENS to extend their license on 23<sup>rd</sup> and 24<sup>th</sup> December.

The Chair asked for there to be a check if Weatherspoon's has been granted a TEN. The Senior Licencing officer left the meeting to confirm if a TEN had been granted.

Mr Cowlard made his representation. Since becoming the Manager 18 months ago only one incident has happened which had been outside the premises. Mr Cowlard highlighted significant progress has been made in the venue with staff training, upgraded CCTV and a new security company with better door staff. Two TENs were granted in October for an extension to 5am. These events had no issue, and the door staffing was increased. There were no noise complaints, complaints from licensing or the Police regarding the October events. Mr Foot confirmed the two previous events have been successful with no issues. Mr Cowlard explained that other venues within the town centre are open until 5am and 6am. In closing Mr Cowlard explained he cannot understand the objection to the current application given that that two notices were granted in October and there were no incidents in the intervening period.

Mr Foot confirmed that the two previous events had been successful and had passed completely unscathed. French's had been closed for 18 months which has had a significant impact on the business. The two previous events had helped the business with measures put in place for there to be no issues.

The chair asked Mr Foot that for the events in October to be successful, would a lot of alcohol need to be sold between 03:00 - 05:00? Mr Foot informed the committee that the town centre can often be busier in the early hours of the morning than it is at midnight. Mr Cowlard answered that the events were also a success due to there being no complaints or incidents at either of the events in October.

PC Spalding asked Mr Cowlard that to pay for staffing for a further two hours a lot of alcohol would need to be sold which is a concern to the police. Mr Cowlard reiterated that the events held in October passed with no issues.

The Licensing Lead, Sussex Police and Mr Cowlard summarised their representations.

### 10 DECEMBER 2021

The Licencing Lead confirmed a TEN for 23<sup>rd</sup> and 24<sup>th</sup> December 2021 which provided an extension from 00:00 – 01:00hrs received on 21<sup>st</sup> October 2021 for Weatherspoon's had not been objected to. PC Spalding noted that the Weatherspoon's TEN predated Inspector Cornwall's letter dated 19<sup>th</sup> November 2021 when the violent crime statistics were available.

The Sub-Committee retired to debate the application.

### **RESOLVED** (unanimously):

### Temporary Event Notice regarding 18th December 2021 and 19th December 2021

This Decision relates to the Temporary Event Notice dated 29<sup>th</sup> November 2021 made by Stephen Foot for temporary event on 18<sup>th</sup> December 2021 and 19<sup>th</sup> December 2021.

We have listened carefully to all the submissions and we are bound to be directed by the promotion of the Licensing Objectives and material consideration of:

- Prevention of Crime and Disorder
- Public Safety
- Prevention of Public Nuisance
- Protection of Children from Harm

### Purpose of Report

To consider an Objection Notice to three Temporary Event Notices (TENs) served on behalf of Flames Grill, 19 Havelock Road, Hastings, TN34 1BP. Responsible Authorities. One.

### Recommendation(s)

1. The Sub-Committee considers the Temporary Event Notices in the light of the objection notice made by Sussex Police and resolves to take such steps as it considers appropriate and proportionate for the promotion of the licensing objectives and determine whether to serve a counter notice.

### **Reasons for Recommendations**

The Sub-Committee must consider the oral representations and information given at the hearing before reaching a decision



# Introduction

# 1.0 Background

- 1. On 7th February 2005 the Licensing Act 2003 came into force for all local authorities, marking the practical commencement of the Government's new liquor licensing regime.
- On the 9th December 2021, Hastings Borough Council was served 1 Temporary Events Notice in respect of Flames Grill, 19 Havelock Road, Hastings, TN34 1BP. (Attached at Appendix A). This TEN was accepted in part only, for the 25<sup>th</sup> December 2021. The two additional dates were non - compliant with the Regulations.
- On the 10<sup>th</sup> December 2021, Hastings Borough Council was served 2 further Temporary Event Notices in respect of the same premises. (Attached at Appendix B).
- 4. This premise holds a licence authorising the sale of late night refreshment, to operate until 02.00 hours from Monday to Wednesday, until 04:00hrs on Thursday to Saturday, until 02.00 hours on a Sunday, Non standard hours until 03.00 hours on a Sunday preceding a Bank Holiday Monday, under the Licensing Act 2003 (Attached at Appendix B), The premise is located within Area 2 (Hastings Town Centre) of the Council Special Saturation Policy (Cumulative Impact).
- 5. This premises licence was subject of a Review brought by Sussex Police in December 2019. In the licensing hearing which took place on the 13<sup>th</sup> February 2020, the sub committee imposed a number of conditions on to the premises licence to reduce the operating hours by one hour meaning they had to close from 03.00 hours. The premises licence holder appealed the decision and the matter was due in court on the 9<sup>th</sup> December 2021. On the 8<sup>th</sup> December 2021, a settlement was reached and the Hastings Borough Council allowed the reduction of hours that Security Industry Authority (SIA) authorised door supervisors, needed to be at the premises. This agreement allows SIA to start at 23.00 hours instead of 21.00 hours.

# 2.0 Application

6. The TEN applications request the following:

25<sup>th</sup> December 2021 03.00 hours until 05.00 hours on the same day,

27th December 2021 03.00 hours until 05.00 hours on the same day,

1<sup>st</sup> January 2022 03.00 hours until 05.00 hours on the same day,



# 3.0 Consultation

- 7. The Act provides for periods of notice and the number of events that may be held. Notice must be given to the Licensing Authority, Police and Environmental Protection ten working days before the beginning of the event period. The Police and Environmental Protection then have three working days to lodge objections with the Licensing Authority and Applicant.
- A copy of the Police objection notice to the TEN, which was received on the 14<sup>th</sup> December 2021, is attached at **Appendix C**. Environmental Protection have not made any representations.
- 9. Objections must relate to the undermining of the licensing objectives, the prevention of crime and disorder, public safety, the prevention of public nuisance, the protection of children from harm. This has been done.
- 10. Senior Licensing Officer Trevor Scrase has prepared a list of other Castle ward venues with late licences, including premises providing late night refreshment. This is attached in **Appendix D.**
- 11. A location plan of the premises is attached at Appendix E.

# 4.0 Legal Considerations

- 12. Part 5 of the 2003 Licensing Act provides a system of permitted temporary activities, under which licensable activities can be carried out on a temporary basis (for a period not exceeding 7 days) without the need for a premises licence or a club premises certificate.
- 13. If an objection notice to a temporary event notice is made by a responsible authority and no compromise can be reached between the parties, a hearing must be held.
- 14. Paragraph 7.28 of the Section 182 Guidance sets how the Authority should decide what actions are appropriate.
- 15. Sch 1, para 1(11) of the Licensing Act 2003 (Hearings) Regulations 2005 confirms the hearing has to take place within 7 working days of the end of the objections period (being 3 working days from service on the objector of the TEN as per section 104(3) of the 2003 Act). But a decision must be reached and the written notice of the decision served at least 24 hrs before the beginning of the event (as per Section 105(4)).
- 16. If the licensing authority receives an objection notice from the police or EHA that is not withdrawn, it must (in the case of a standard TEN only) hold a hearing to consider the objection unless all parties agree that this is unnecessary. The licensing committee may decide to allow the licensable activities to go ahead as stated in the notice. If the notice is in connection with licensable activities at licensed premises, the licensing authority may also impose one or more of the existing licence conditions on the TEN (insofar as such conditions are not inconsistent with the event) if it considers that this is appropriate for the promotion of the licensing objectives.



- 17. If the authority decides to impose conditions, it must give notice to the premises user which includes a statement of conditions (a "notice (statement of conditions)") and provide a copy to each relevant party. Alternatively, it can decide that the event would undermine the licensing objectives and should not take place. In this case, the licensing authority must give a counter notice.
- The Department for Culture, Media and Sport has issued guidance under Section 182 of the Licensing Act 2003. This guidance is provided to Licensing Authorities to assist them in carrying out their functions.
- 19. All members of the Licensing Committee have previously been supplied with copies of the DCMS Government guidance and the Hastings Borough Council Statement of Licensing Policy.
- 20. Human rights considerations must be taken into account fully in balancing licensing issues, in particular, Article 1 of the first protocol and article 8. Article 1 relates to the protection of property and the peaceful enjoyment of possessions and property. Holding a premises licence would be considered a possession. Article 8 relates to the right to respect for private and family life, home and correspondence. These are however qualified rights and can be deprived of "in the public interest". Interference is permissible if what is done:-
  - Has its basis in law;
  - Is necessary in a democratic society to fulfil a pressing need or pursue a legitimate aim;
  - Is proportionate to the aims being pursued; and,
  - Is related to the prevention of crime; or, the protection of public order or health.

If members choose to issue a counter notice there is a right of appeal.

### **Right of Appeal**

Under the provisions of Section 181 and Schedule 5 of the Licensing Act 2003, there is a right of appeal against the decision of the Licensing Committee if the applicant is aggrieved at the outcome. Where the relevant licensing authority gives a counter notice, the premises user may appeal against that decision.

Where that authority decides not to give such a counter notice, the chief officer of the police or environmental health department of the local authority may appeal against that decision.

Full details of all the rights of appeal can be found within Schedule 5 of the Act. Any appeal should be made to Hastings Magistrates Court, Bohemia Road, Hastings within 21 days from the notification of this decision but no appeal may be brought later than five working days before the day on which the event period specified in the temporary event notice begins. You must contact the Magistrates Court to establish the formal procedure for the appeal.



# RE; TEMPORARY EVENT NOTICE (TEN) x 3 for Flames Grill, 19 Havelock Road Hastings East Sussex. TN34 1BP. NOTICE OF OBJECTION under Section 104 (2) of the Licensing Act 2003

Notice of objection is hereby given on behalf of the Chief Officer of Police for Sussex for the above TEN'S on the grounds of the licensing objectives of prevention of crime and disorder, public nuisance and public safety not being promoted.

We received 1 Late TEN on Friday 10th December 2021 for 25<sup>th</sup> December 2021. We also received 2 further TEN'S on Monday 13th December for 27<sup>th</sup> December 2021 and 1<sup>st</sup> January 2022. All the TEN'S seeks to licence late night refreshments between the hours of 0300-0500.

Sussex Police has seen an increase in violence in the night time economy since lock down was lifted earlier this year. There is also the added concerns of violence against women and girls with an increase in suspected spiking incidents. Recently Sussex Police obtained up to date crime statistics to see if we had enough evidence to support the continuation of the Cumulative Impact Policy (CIP) which is currently under consultation. The results highlighted there was very much a need to continue with the CIP and therefore we fully support its continuation. Our records show that Havelock Road is within the Hastings Cumulative Impact Policy.

The Castle Ward has the fourth highest public place violence rate in Sussex. Crime is at its highest during the night time economy during week days as well as weekends. Overall we have seen an increase of approximately 49% of public place violent crimes in the Castle Ward.

East Sussex Licensing Team Police Station, North Trade Road, Battle, East Sussex TN33 0EX Sussex Police reviewed the premises licence for this premises in December 2019 and the hearing took place on 13<sup>th</sup> February 2020. On 13<sup>th</sup> February 2020 the Licensing Sub Committee made a decision to impose a number of conditions on to the premises licence and to reduce the operating hours by one hour meaning they had to close from 0300hrs. The premises appealed the decision and the matter was due in court on 9<sup>th</sup> December 2021. On the 8<sup>th</sup> December 2021, a settlement was reached and the Local authority allowed the reduction of hours SIA needed to be at the premises. The agreement was to allow SIA to be at the premises from 2300hrs as opposed to 2100hrs.

The premises does not sell alcohol but we have proven in the past they suffer from those who are intoxicated leaving nearby premises. Being allowed to increase their hours at such a busy time of the year, we believe will only increase the risk of crime and disorder and public safety for not only the public but also for the staff.

Allowing premises to increase the operational hours whilst crime rates are so high, would not only add to the increase in crime and disorder but also add pressure to the emergency services. Therefore, the Chief Officer of Police contends that permitting TEN to be used in accordance with the notice is likely to undermine the licensing objectives of the prevention of crime and disorder, public nuisance and public safety.


