Your letter dated 11<sup>th</sup> of July 2018 second paragraph states: "we have received information from Rother District Council, of the fact that as a result of the enforcement action leading to the review of the premises licence for The Chilli Tree Asian Cuisine, 1 King Offa Way, you have been required to pay an immigration penalty".

The statement made by you as indicated above clearly points out that someone from Rother District Council has phoned or by other communication has told you of the relevant issues as you have mentioned. By your own admission you cannot deny that although I am aware that you will not reveal the name of the person who has informed you. Given the fact that the case has been in the public domain as you suggest for many months now so it is necessary to question why you have contacted me after almost two months of the case now in the Courts appeal process. I can almost assure you, that it is Melanie Robson from Rother District Council who has made contact to you and perhaps directed you to the Rother District Council website for a full case reading, it has to be as I cannot think of any other way. Also given the fact that Observer printed an article on their Online Webpage, Local Facebook page it was all smothered over and also the Observer printed two separate articles concerning the Chilli Tree yet nothing was forthcoming from Hastings Council.

As you have mentioned in your 11<sup>th</sup> July letter 2018, someone from Rother District Council has contacted you and I believe that to be true. However, what little or more they have told you, they have not been truthful which is that the who case is in the process with the Courts, the immigration issue is also with the Home Office jurisdiction and the whole penalty being appealed.

At the same time Melanie Robson has also made other allegations about me for which I have included a copy and that is being taken through the Court process for 'slander' separately simply because Melanie Robson has no evidence and she is trying her very best to discredit me and my business — but the more she is trying to do that the more, it is working in my favour.

Your response on the 26<sup>th</sup> July 2018 is very different where on paragraph two you state: "The information regarding your premises licence review is in the public domain and can be viewed on line...". I am not talking about the information that can be viewed online, I am asking you to answer my question where you state that you have received information from Rother District Council so that means that someone from Rother District Council has made you aware of it. I do not think I am being wrong there but what I have established here in the two communications that you have sent me is a lie, I am not happy about that at all. By all means you can make an application to revoke my licence and I have the right to refer this case to the Local Government Ombudsman in order to establish that someone somewhere along the line is not telling the truth. In the Magistrates Courts I will appeal it like the other Premises Licence case.
