This premises is comprised of a Family Entertainment Centre and, to the rear of the premises are two Adult Gaming Centres. The premises holds two separate Adult Gaming Centre Premises Licences in respect of two units situated within the Adult Gaming Centre. The Licensing Team seek to review all two of the Premises Licences as the units are located adjacent to each other and form the whole Adult Gaming Centre part of the premises.

On 22nd April 2014, the premises was subject to a test purchase, conducted by Hastings Borough Council Licensing Team in partnership with the Gambling Commission. Two young people; one male, one female (one seventeen and one sixteen years old) was able to enter the Adult gaming Centre at 13.17 hours and play on an age restricted Category C gambling machine. There were two members of staff present during the time that the young person was on the premises. The young people left the premises ten minutes later without being challenged at any time by staff.

Stade Developments (Hastings) Ltd were written to by Mr Bob Brown; Licensing Manager, Hastings Borough Council's Environmental ServicesLicensing Team, on 23rd April 2014 to confirm that they had failed this test purchase and had committed offences under Sections 47 and 46 of the Gambling Act 2005.

On Tuesday 6th May 2014 at 12.00 noon a representative from your company attended an interview with Mr Brown to discuss the test purchase operation.

On 30th October 2014, the premises was subject to a second test purchase. Two different young people (fifteen year old females) was able to enter the Adult gaming Centre at 13.05 hours and play on age restricted Category C gambling machines. There were visible members of staff on the premises, behind the cash desk and walking around. The young people left the premises approximately thirteen minutes later without being challenged at any time by staff. A plain clothes policeman, PC Mark Charlton acted as Police Supervising Officer during this visit and was present during the whole time that the young people were in the premises. Mrs Davies, Lead Local Authority Officer, made written notes of what had occurred during their visit immediately after the visit (Appendix E).

The premises has now been the subject to two test purchases and failed both after receiving advice following the first. It is clear that the licensing objective: Protecting children and other vulnerable persons from being harmed or exploited by gambling, is not being promoted effectively.



<u>Application for the review of the premises licence HOAGC04/HOAGC17 – Flamingo Arcade, East Beach Street, Hastings East Sussex TN34 3AR</u>

Supporting Information

The Flamingo Arcade, Areas 1 & 2

The premises at East Beach Street in the Old Town are comprised of a single storey building fronting onto the promenade and adjacent to the Stade Open Space. The front of the building which has multiple openings (including the right hand side opening onto the children's fairground ride area) comprises a large Unlicensed Family Entertainment Centre with Category D machines. i.e. crane grabs and shove penny machines etc.; these types of machines are all legally available to be played by children under 18 years of age.

At the back of the internal floor area and to the west side are the two Adult Gaming Centre areas.

Regulated Activity

Section 172(1) of the Gambling Act provides that the holder of an Adult Gaming Centre Premises Licence may make available for use up to four category B machines; any number of category C machines; and any number of category D machines. Regulations specify that the category B machines should be restricted to sub-category B3 and B4 machines.

Adult Gaming Centres

In order to have their full quota of the higher pay-out machines; Category B3 & B4, the area holds two separate licences for which they pay an annual fee on each licence.

Protection of children and young persons:-

No one under the age of 18 is permitted to enter an AGC

There are a number of Mandatory Conditions attached to an AGC Premise Licence:-

A notice must be displayed at all entrances to AGCs stating that no person under the age of 18 years will be admitted to the premises.

There can be no direct access between an AGC and any other premises licensed under the Act or premises with an Family Entertainment Centre, club gaming, club machine or licensed premises gaming machine permit,

Test Purchase Operations

First operation - 22nd April 2014.

This was a test purchase operation of six gambling premises, including Adult Gaming Centres and betting shop premises within the Borough that are licensed by the Authority under The Gambling Act 2005. The Flamingo Arcade is one of these premises.

The operation was run by the Senior Licensing Officer, Trevor Scrase, accompanied by an undercover police officer and a representative from the Gambling Commission. The test purchasers were two sixteen year olds, a male and a female.

The purpose of the operation was to test the effectiveness of underage gambling policies and procedures at gambling premises within the Borough. The operation was carried out in accordance with the Gambling Commissions guidance on these matters.

The undercover police officer entered the premises first to conduct a risk assessment, the two young people followed several minutes later. The young people were able to play on the machines unchallenged for approximately 8 minutes.

As a result of the failure to challenge the underage young people, Stade Developments (Hastings) Limited, the company who manage and run the Flamingo Arcade and for other premises within the Borough were written to on the 23rd April 2014. A copy of that letter (appendix B) is attached to this Appendix.

As a result of that letter a representative from the company, Jan Hall, came to a meeting with the Licensing Manager, Bob Brown, on the 6th May 2014 and assurances were given by Mrs Hall that the procedures and policies operated by Stade Developments (Hastings) Ltd would be reviewed and tightened up.

Second operation – 30th October 2014

The second test purchase operation was conducted in exactly the same way on the 30th October 2014. The operation was led by Michelle Davies, a Licensing Officer with Hastings Borough Council, accompanied by a different undercover police officer and a representative from the Gambling Commission. We had three 15 year old girls as our test purchasers on this occasion.

The Flamingo Arcade was the first on our list of re-tests from the first operation plus two additional premises. After the police officer entered the premises to conduct a risk assessment, two of the girls were asked to enter the premises via the unlicensed Family Entertainment area and make their way to the Adult Gaming section of the arcade. They had been briefed by the Gambling Commission Officer on what to expect in an arcade and in the adult gaming centre including what types of machines

and how to operate them as they had not done so before. The girls entered the adult gaming area and played on several machines despite the presence of staff members at the cash desk and on the floor area and were not challenged at any time. They entered the premise with £20.00 and left approximately 13 minutes later with £11.00. Immediately after they returned Mrs Davies asked both girls the prepared questions on the pro-forma (copy attached-appendix C) They handed back the balance of the money to Mrs Davies and proceeded on to the next premise in the operation.

Summary

The premises along with 5 others in the Borough failed the initial test purchase earlier in the year and were written to by the Licensing Manager, at his request a representative from the company attended a meeting with the licensing manager and assurances were given that policies and systems would be put in place to ensure that this could not happen again. Just over six months later and during the school half term period when it could be reasonably expected that there would be an increased number of minors "out and about" in the town and seafront area, therefore it would seem appropriate that the company would ensure extra vigilance was in place. This was not the case and the two young ladies were able to enter and gamble in an adults only area without challenge.

Conclusion

Although other premises, 8 in total, were tested on that day, this was the only one that had also failed on the previous operation, although two other premises also owned by the company failed that day, this was their first failure and it was felt that a warning letter and a further meeting with the company to discuss their plans to make the underage prevention procedures more robust would be an appropriate course of action in those cases. However, with this particular premise failing for the second time, the open access to the main FEC complex and proximity to the "fairground" rides on the Stade area, I am of the opinion that a review of the premises is justified.

Hasting Borough Councils Gambling Policy states the following:-

- 3.5 Protection of children and other vulnerable persons
 - 3.5.3 In relation to children, it should be noted that the Gambling Commission has stated that this objective is explicitly to protect them from being harmed or exploited by gambling. This means preventing them from taking part in gambling.
 - 3.5.5 The Licensing Authority will generally expect those who operate or control gambling premises or gambling events to have regard to child welfare.
- 3.6 Access to licensed premises
 - 3.6.1 With the exception of bingo halls, non-gambling areas of tracks on race days and licensed family entertainment centre, children will not be permitted to enter adult only licensed gambling premises.

The review **does not** seek revocation or suspension of the premise licence but I ask that the committee considers the below recommendations, as set out below, some or all of which may be appropriate to secure this area.

Recommendations

Require the Cat C & B3 Gaming machines comprising the AGC are to be repositioned so that they are fully adjacent to the ticket/change office, or vice versa, allowing the entrance and area to be fully monitored at all times.

Permanent supervision of the AGC entrance

Physical barrier that prevents open access to the AGC area-requiring customers to ask staff to let them in or operate a token only entrance system following robust age related checks.

Floor walkers at all times with particular attention being paid to that area.

Compulsory third party test purchasing on a frequent basis (monthly?)

Monitored audio alert so that staff are aware that someone has entered the area and a system in place to show that this is followed up and recorded.

I am employed as a Licensing Officer by Hastings Borough Council, I am based at Aquila House, Breeds Place, Hastings TN34 3UY. I have held this position since August 2008. I am an Authorised Officer for Hastings Borough Council under The Gambling Act 2005 and The Licensing Act 2003. I am also a holder of the BIIAB National Certificate for Licensing Practitioners (Gambling). On Thursday 30th October 2014, I attended a briefing meeting held by Bob Brown, Hastings Borough Council Licensing manager, in order to conduct a test purchasing operation on 8 premises licensed under The Gambling Act 2005 within the Borough . Also at the meeting were, Trevor Scrase, Senior Licencing Officer, Andrew Isaacs, Gambling Commission Compliance Manager, PC Mark Bright and three fifteen year old females who were going to act as 'test purchasers' on this occasion This was to test the underage gambling policies and procedures at premises licensed under The Gambling Act 2005 including adult gaming centres which contain gaming machines to which persons under the age of 18 are not permitted access under any circumstance and not to be allowed to play the machines in this adult only area. Immediately following the briefing I took photographs (head and full length) of all three girls as evidence of their appearance and clothing during the operation. Prior to the commencement of the operation and as suggested by Andrew Isaacs,

we took the girls into a public house where there were known to be licensed Category C Gaming machines to show them the type of machine they may find in the venues as none of them had been in an arcade previously and to give them confidence in identifying how the machines were played i.e money slots, press, hold, play buttons etc. We then proceeded to the first venue on our list which was the Flamingo Arcade on East Beach Street. At approximately 15.00 hrs, PC Charlton entered the premises first carry out a risk assessment prior to the girls entering the premises. The young ladies were sent in some minutes later with twenty pounds as playing money asking them to make their way gradually towards the adult gaming area. Mr Isaacs, myself and the remaining young person remained outside at some distance away. At approximately 13.18 they returned to us and reported their findings to me as I completed the pro-forma questions in relation to how and when or if they had been challenged by the arcade staff on duty. They reported that they had not been challenged at any time and had played on machines with a jackpot of £35.00 and £70.00 and had spent £9.00. Pc Mark Bright also left the premises and re-joined us. We then moved on to the next venue.

I am employed as a Senior Licensing Officer for Hastings Borough Council, based at Aquila House, Breeds Place, Hastings, TN34 3UY, I have held this position since June 2006, previously I was the Licensing Development Officer from November 2004. Prior to employment with Hastings Borough Council, I was a police constable in Sussex Police, completing thirty years' service in November 2004. I am the holder of the BIIAB Level 2 National Certificate for Licensing Practitioners in Gambling, which is an accredited qualification. On Thursday the 22nd April 2014, I was appointed the 'lead officer' in a test purchase operation of six premises in Hastings & St. Leonards, licensed by this authority under the Gambling Act 2005. These premises were registered as adult gaming centres or betting shops. I was in company with PC Christopher TREVENA, Hastings Police, Mr Andrew ISAACS, Gambling Commission Compliance Manager, a sixteen year old female and sixteen year old male who were acting as 'test purchasers' in accordance with their briefing by Mr Robert BROWN, Licensing Manager. One of the premises was the Flamingo Arcade Amusements, The Stade, Hastings, which is licensed as a family entertainment centre with two 'adult gaming centres' located at the rear of the premises. The purpose of the operation was to test the effectiveness of the premises policies in respect of underage access to the part of the premises licensed as an 'adult gaming centre' which contains gaming machines to which persons under eighteen years of age are not permitted access, in the area beyond the 'no under 18 signs' or to play the gaming machines of category B or C. At 13.17 hours, PC Trevena and Andrew ISAACS entered the premises, followed by the two

Re: Test Purchase Exercise.

Hastings Borough Council has been working in partnership with the Gambling Commission and as a result conducted a series of test purchase operations in Gambling Premises earlier this year. The tests were designed to test the effectiveness of underage gambling policies and procedures at those premises.

The Authority tested six premises of different types in the expectation that it would supply us with evidence that operators have sufficient safeguards in place to prevent underage gambling. It was very disappointing to note that all six premises failed the exercise, in each case the two underage persons used were allowed unchallenged access to the premises and to play the machines.

All operators involved in this operation have now attended these offices to discuss the findings of the exercise and accepted that their operation needed tightening up. The Authority was pleased to note the commitment by each operator to ensure that their operating procedures reflected our concerns and their assurances that staff will be even more strident in their approach to underage sales in the future.

The Authority felt it important to raise this issue by letter with all premises licence operators across the Borough, to give you all the opportunity to consider your own policies in the knowledge that the Authority will undertake similar operations in the future with hopefully a much improved result.

Review of premises licences HOAGC04 and HOAGC17: representation submitted by responsible authority

This representation is submitted to the Licensing Committee of Hastings Borough Council by the Gambling Commission as a responsible authority under section 157 of the Gambling Act 2005 (the Act), in accordance with section 200(5) of the Act, and in respect of the reviews of the adult gaming centre premises licences held by:

 Stade Developments (Hastings) Limited, Flamingo Arcade Areas 1 and 2, East Beach Street, Hastings, TN34 3AR

The representation is made with reference to the third licensing objective at section 1(c) of the Act, specifically the objective of "protecting children.....from being harmed or exploited by gambling"; and to the Commission's codes of practice issued under section 24 of the Act, specifically the social responsibility code provision 3.2 concerning "access to gambling by children and young persons".

The Gambling Commission supported the test purchase operations conducted by Hastings Borough Council on 22 April 2014 and 30 October 2014, the latter to re-test licensees whose underage gambling controls had shown to be ineffective during the April operation. We were in attendance with the council on both days.

The Commission attaches a high priority to the prevention of underage gambling, as it is one of the key licensing objectives of the Act that children are protected from being harmed or exploited by gambling; it is the responsibility of gambling licensees to manage the risks to this objective that their premises may present. Section 46 of the Act makes it an offence to permit a child or young person to gamble, and section 47 makes it an offence to permit a child or young person to enter adult gaming centre premises.

The Commission's Licence Conditions and Codes of Practice (code provision 3.2) require adult gaming centre licensees to have policies and procedures in place to prevent underage gambling, and to monitor the effectiveness of these. Many gambling operators provide the Commission with frequent, robust evidence that they are monitoring their controls, for example through the commissioning of independent test purchasing of their premises. However, the Commission works with licensing authorities across England and Wales to conduct test purchasing among licensees who do not provide it with such evidence. The gambling licensees tested on 22 April 2014 had been identified by the Commission and Hastings Borough council as those that do not provide such evidence. Test purchasing is therefore one means by which the Commission and licensing authorities will measure the effectiveness of licensees' underage gambling controls, in the absence of adequate data provided by licensees themselves.

The results in Hastings are reflective of the test purchase results from other parts of England and Wales, and the Commission encourages regulatory action by licensing authorities where local gambling licensees fail to improve their controls. The Commission's press notice published on 2 September 2014 warned all gambling licensees that "....local authorities are reminding the operators that if they fail to voluntarily deliver improvements, or if their gambling premises fail a further test purchase, then they may be subject to a review of their premises licence which could culminate in the imposition of stricter licence conditions or the suspension or revocation of their premises licence".

The Commission therefore supports the reviews of these premises licences by Hastings Borough council in view of the weaknesses in underage gambling controls that were demonstrated at these gambling premises in the April and October test purchase operations.
